## **Pre Amble:**

### **RFID Implant Charges:**

Human Rights Breaches of Torture, Victimisation, Persecution and Conspiracy to Pervert the Course of Justice, Conspiracy to Murder and Attempted Murder:

I want to bring Human Right charges for an RFID implant the dentist in Fuengirola Alex McCubbin B.D.S. (British Dental Association) put in me with his wife assisting him, Blanka McCubbin (Also known as Blanka Recknagel) from <http://englishdentalpractice.com/> Fuengirola, Address and details below.


I saw and remember the dentist put the RFID Implant in using a needle identical to the one in the picture below. I asked him at the time what it was, it's a bit big I said, he said it's new and would not hurt. Later when i found out about the technology, i realised right away it was Alex McCubbin

that implanted me with an RFID Implant. He used the same needle twice once on each side of my inner mouth close to behind each of my ears.



Small RFID Implant chip, here compared to a grain of rice, is incorporated in consumer products, and implanted in pets, for identification purposes. They are programmable and can run Neurophone software (Neurophone information in the legal pack). So they can track and be used for listening to people plus they can be tasked to receive a signal so they can talk to you through the Implant.

They are using this implant to talk in my head, and listen to my thoughts. Thoughts are formed audibly in the mind and can be listened to. They also inflict pain using the implant. I have a continuance high pitched noise to distract the conscious mind so they can plant subliminal suggestions, i understand this technology perfectly and have provided documentation to show its function and purpose.



It's also possible he put a tracking implant in a tooth replacement. It was a long piece of cylindrical metal that can be tracked from space satellites, i can provide technical specs if needed.

The device that was planted in me looked very like this but more metallic looking, but about the same exact size, the tooth acrylic then went on top of it.

**We will be able to demonstrate the technology to the court.**

While i was in Fuengirola I started hearing the voices of those victimising me inside my head, shortly after visiting Alex McCubbin's Dental practice to have a tooth replaced. At first the voices i started hearing seemed like they could be someone on the other side of the wall messing about.

On one occasion i caused a scene, as i did not know what was happening, that caused two local police officers to come to my home. What had happened was i could hear people out in the street talking about me. I now know it was the start of the electronic terrorism and they were in fact using the implant to mess with me. I would like these two Local Police to be interviewed as to how and who spoke to them.

After hearing the voices for some time, I decided to move out of Fuengirola to Torrox. There were no buildings nearby at the new location. As a result, and still hearing the voices that were now able to hear my pre cursor thoughts, (most likely as they were now using MAE Microwave Audio Effect documents attached that explain the technology) and reply to me inside my head that only i could hear. I started to look for a tangible way this could be done.

I had seen TV programs on pre cursor thought recognition that showed that you could tell what someone was thinking before they said it up to six seconds before in some cases. Plus I knew about military Bone Mikes and the data functions of them. Also RFID implant chips on dogs. So i quickly worked out the broad strokes of the technology. Over the last few years i have learned the technology to the point where i can now make it and demonstrate it to the court.

I thought back as to when this RFID Implant could have been put in me and there was only one possibility. As soon as i saw the image above of the needle i knew instantly that's what had been done by Alex McCubbin. Other techniques are used in conjunction with the Implant, i have provided information on these.

I quickly found out that it was being used all around the world to harm people. The same thing has been going on with me. The obvious tracking and invasion of privacy laws it breaks, not to mention the Human Right violations carry a life sentence under EU law.

I have a constant loud ringing in my head and pain, and have suffered physical damage, I wake up and my head is so hot, it's because they are bombarding me with Microwave radiation. This is attempted murder.

### **Electroencephalogram (EEG)**

(As part of Conspiracy to Murder and Attempted Murder:)

Another thing they have been doing is using Electroencephalogram (EEG) projections using EEG mapping. What this does is send an electronic signal to my nervous system and they can make you do things like jerk your arm when I'm driving the car which they have done to me several times, it's like warning me, if i try to get justice they will try and kill me.

They use Microwave Auditory Effect (a fine beam of focused microwave) and using a Neurophone to record EEG signals from my body and then playing them back via the MAE device or Implant. What this does is record a pain you have via the EEG and Neurophone and then they play it back at you via the Implant or directly to the nerves involved with MAE. This has the effect of then replicating the pain you had over and over, its torture, plain and simple and carries a life sentence, i expect this sentence to be issued and carried out to the full extent of the law.

I want everyone who has used this EEG system arrested for conspiracy to commit murder, because that's exactly what it is. I have attached the documents that prove how this is done and it was done as early as 1979 by the security services in the USA and UK, including the Russian Woodpecker program also around the same time.

I have informed UK National Security who put the implant in via Anna Timmins of the British Foreign and Commonwealth Office; they cannot act here in Spain, and suggested i report it as a crime here in Spain.
