Dear Sir/Madam

I would like an investigation in to what is going on in a case that i was extradited to Spain for, the case relates to Court No. 4 of Marbella, its regarding a case from 25 years ago, i have written to you 25 years ago and recently sent an email to you with information. The original judge in my case was sent to prison, and i was falsely imprisoned and have Spanish legal documents that prove this. Please read the information below, i expect action at the highest level.

22 years ago the Under Secretary of state intervened in my case and came to Madrid MI6 agents were used to investigate what went on and as a result i was released and the Judge in the case was dismissed and brought up on charges of corruption, we witnessed and have proof of the corruption first hand.

I want to know exactly who has been involved in this from start to end and i will be going to the newspapers and suing everybody involved. I want the fiscal and court number four arrested AGAIN! Also any British MI6 Agents or Police staff involved arresting and deporting from Spain. This is a massive miscarriage of justice and it will cost Spain, you need to arrest the people behind this and end my case NOW!

I want a lawyer to get me an interview with RT TV so i can tell the truth to the UK of whats going on. I was until this started a very successful musician, signed to Polydor, and a member of the BASCA (British Academy Of Songwriters).

Can you help me? There are some cases that can be done quickly and one case where i took the company to court via an industrial tribunal, i won and they awarded me 80,000gbp and gave me

leave to go further for 1m gbp. I want to sue the Mason lawyers that would not do this for negligence; they have indemnity insurance and would settle out of court if pressured.

I have had my career ruined by drug dealers and mafia/masons, I want to expose all this. All my communications are compromised so you may get this several times from different locations, they have planted a bug in my body and I am under surveillance 24 7, they are conducting Mason warfare on me using RF devices and Microwave radiation, I want to bring attempted murder charges against all the people involved in Spain and the UK.

If you want to run with this it will have to be done from Spain, as they wont let me leave. They have taken my passport, I dont have anything re-documentation, I do have all the proof that any half decent investigative journalist will be able to run down in a short time.

## Letter Sent To RT TV and UK Prime Minister

Dear Sir/Madam

I was recruited to MI6 by Charles Formby (son of George Formby famous musician) from the Seville British Embassy in Spain. I had to report to Senior Liaison officer Paul Studley MI6 at the British Embassy in Madrid, (I was told this and had it confirmed that it was MI6 by Mr Formby) and another liaison officer called Toby Child also MI6.

I was investigating major drugs trafficking on the Costa Del Sol and Costa Blanca coasts in Spain for MI6. I found out during my investigations that the British Freemasons were running the drugs trade in the UK. The way it works is that all the leaders of the Costa drug gangs (the British Drugs Mafia that the UK government says does not exist, and is in fact run by them) all belong to the masons, it sounds not true, but I can name the guys and the lodges they are in, they even have their own Drug Trafficker lodges.

The Masons stole a 2 billion pound company from me (I was CEO & Chairman owning 51% of the voting shares) by using an untrue case in another country to discredit me and then by putting a gag order on the UK press, I cant get the story out as they are stopping me.

I know this as I spoke with a well-known investigative journalist Wensley Clarkson who took the whole story down and got several British newspapers to agree to run the story including the Sun, then he disappeared, the last time he contacted me he told me my life would be in danger if they run the story, but it was because the papers could not run the story due to MI5 gag order on me, to contact them prior to print, I was told this by an MI5 Officer Paul Cullumbine in Spain.

I then contacted a military friend and he got a top UK TV producer to look at the story, he was scared off the story, he initially wanted to do a TV program, then MI5 got to him, he is a top producer for ITV, his name is Alexander Gardiner.

The Masons and MI6 hatched a plan to steal my business and ruin me, Anthony Keaton from MI6 (undercover operative with the IRA) gave information to my business partners illegally (Ralph Keaton his Brother, and Martin Burr all three from the same Masons lodge in Scunthorpe), they then ring-fenced me and have a Gang Stalking order on me to ruin my life and stop the ugly truth from coming out.

MI5 became involved at this point, three people approached me to back my business plan, Terry Plumber, Wayne Lochner and Chris Briton all MI5. They got all the information on my business by doing due diligence, as it proved to be a very worthwhile business. Richard Thompson (UK Rich List and Mason) put up two million pounds to trial the business. I decided to go with the McCarthy

Corporation that owned one third of most Virgin businesses then. They offered me four million pounds, once they realised it worked they Ring fenced me.

Once i started to complain and wrote to my MP they fabricated the story about the Spain case, which was a farce in which the judge went to prison, the whole court were put in prison. They had me extradited to Spain on a charge from 25 years ago, to shut me up where I have been for 6 years, I have been followed continually and have had Spanish secret service talk to me saying it being done through Madrid by the UK.

I want to sue the various people and organizations for 2 billion UK pounds based on the company they stole from me, MI5 MI6 and the Masons, (MI5 was the first client of the new company! After they stole it from me) plus damages they have done to my music career, businesses and family, there are human right abuse issues, purgery issues, perverting the course of justice issues, victimization, stalking, and more. I want to bring private prosecutions against all parties.

When I was extradited on the 25 year old Spanish case, there is no charge and never was, it was all done in CAMERA ask yourself this question, if I am not telling the truth why did they hold all my hearings in CAMERA, the only people this happens to is MI6, MI5 and national security issues.

There is much more to this story including an incredible story of corruption in Spain with British Drugs Mafia paying police to land drugs in the main sports ports on the coast, it also involves corrupt Spanish officials, when the case was brought against me 25 years ago I was released without any bail money and no charges. The judge in the case was sent to prison and brought up on other corruption charges and the British government intervened on my behalf, the Undersecretary of state flew to Madrid and got the case squashed due to known corruption in the case plus that they knew it was the British Drug Mafia who committed the crime.

Thats when I was introduced to MI6 as they investigated my case on the say so of the secretary of state for the UK. I wanted to help get the perpetrators so I let them recruit me. I have a telegram and lots of supporting evidence of this, and also have evidence of the theft of my business. It can all be proved they just dont want it proved!

There is another twist here, and thats why they are ring fencing me, I am the lead guitarist with A II Z (paste it in google) [www.aiiz.co.uk](http://www.aiiz.co.uk) they know I am friends with some very well-known people in the music industry, I want to use this to up the publicity as strong as its possible to do.
