Jayne Owens called the Royal Mail 12 th December 2015 re delayed mail from Spain
First call: Belinda (Royal Mail) between the 12 th 14 th December 2015
After a long conversation with Belinda giving her all the tracking numbers she put the info into the system but did not get any more new information that we hadn't already got off of the royal mail online tracking service. Belinda took my phone number and said she would try and get more information and call us back. (I gave her my phone number).
Before the conversation finished at some point I asked her, her opinion on the delayed mail she thought it very strange and could not understand why it would take so long.
Conversation Ended
Call Back from Belinda (same day) Royal Mail 12 th December 2015
She said she had just found out information she did not know when sneaking to me before that

She said she had just found out information she did not know when speaking to me before that she had been told there was a Hugh back log of international mail and the back log would not be cleared until the 20th so should go out then, but was not definite. So she said call back on the 20th.

Conversation Ended

Two more calls: Jenny Jenkins Royal Mail 14th and 21st December 2015

Called Royal mail on the 21^{st} December as the mail on the tracking service on the internet still stated the letters was still in Heathrow clearing.

Spoke with Jenny Jenkins again explained the situation regarding the mail being delayed, that we had posted it on the 27th November 2015 from Spain and that it arrived in the UK on the 2nd December 2015. She thought as Belinda it was very odd.

I asked Jenny if she knew of any reason the letters would be delayed this long has there been any strikes and back logs in mail.

Jenny's reply was "No not anything that would warrant this kind of delay"

She said she was going to speak to the person higher than herself whom would have more clout. And she would get back to me after passing the information on. She gave me her email address .

End of conversation

Jayne Owens did not hear from anyone so emailed jenny on the 22nd December telling her I had not heard anything she replied to me the same day and said she would get her manager to get in touch.

I received an email on the 22nd December from the manager asking for full info of all the mail we have sent, tracking numbers etc.

Jayne Owens received a call from Rebecca Redmond on the 23rd December 11:40

She asked for me to send all info as she had on the email

I asked her what her thoughts were on the delay of the letters

Her reply was quite different "I think they have probably been delivered but not signed for "

Which I thought was not likely as they were all to different places and the chance of all not been signed for is very unlikely.!!!

Thank you for allowing me the time to investigate the whereabouts of five items that you sent to the UK from Spain.

After completing my investigations, regrettably I must inform you that I am unable to provide you with any further information than can be seen on the Correos tracking system.

The recipients of each of the five letters you sent, that are not tracked as delivered, receive a vast amount of mail each day. Their mail is delivered in bulk and it is possible to erroneously miss a scan, resulting in no tracking information being provided. It is possible these items have been delivered.

I have contacted the recipient's main offices to see if I could confirm delivery, however due to the considerable amount of mail they receive they were unable to provide me with this information.

If you wish to proceed with your investigation, you will need to contact the sending postal authority (Correos) who will raise an enquiry with Royal Mail.
