There is an Evidence Pack that is available to the court investigators, in my presence only, as not one person i have met in the justice system is straight! This contains finger prints of all the people involved and many other clear points of evidence. They won't be leaving my sight.

Audencia National Case:

We are asking that this case go directly to the Audencia National judicial police, due to the corruption in the justice system and policing surrounding this case on a national and international basis.

There are local people involved in criminal aspects of this case, the Guardia Civil are the right force to use to arrest the people named in the Denuncia as most are drug traffickers from the

British Drug Mafia.

I want the Denuncia to be official so i will register it with the National Police, Provincial Commissioner, this is because almost all of what has happened in this case is the Del Sol wide and all within Malaga.

This Denuncia is about a conspiracy to pervert the course of justice, by the UK Government, MI5, MI6, NCA, Masons, and the British Drug Mafia. Pre Amble Desired Outcome, Without Prejudice:

I reserve the right to act in self defence, based on the fact that i have asked for protection from several wards of the court, and received no help. My family and i have been put in danger by corrupt police and courts unwilling to act against the British Drug Mafia and Judicial Mafia on the del Sol. In the absence of justice and law and order i have been left with no alternative. You arrest these people now or i will, and i will interrogate them and track down everyone involved.

This whole thing has been orchestrated by Masons using the British Drug Mafia & Gang Stalking, Backed by Corrupt Police and National Crime Agency Masons plus manipulation of Europol/Interpol. They have deliberately misled the courts and brought about the whole extradition and case that you are now reading, duping the Spanish authorities to cover up the crimes they have committed.

I have been told by both Spanish court functionaries and Spanish undercover police that the case is being manipulated from Madrid via NCA Masons. I know because of what has happened prior, that this is all Mason related, I want all the people involved arrested and questioned including the people that told me about Madrid.

I would like the court to consider using organised crime laws against these people. Enforcement of RICO (Proceeds of crime laws) against the British Drug Mafia and Masons in Spain.

The British have managed to get around this by pretending the Masons and British Drug Mafia are not an organised Mafia. My case clearly proves that not only are they an organised Mafia, but they have been for at least 30 years, and so RICO should apply and be backdated for that length of time.

The same process can then be used on all other Mafia's in Spain, like the Rumanian Mafia, Bulgarian Mafia and many others.

The outcome of granting my request would be that the Spanish Government would gain around Ten Billion Euros in ceased bank accounts, properties, businesses, cars, yachts and so on, just from the British Drug Mafia. If you multiply this by the other Mafia gangs you would be able to recover around 100 Billion Euros.

Out of the assets that are taken under RICO, people like me, who have been wronged by them, should be compensated. The rest goes to the regeneration of the coastal areas of Spain to counter the fact that the Mafia's would be leaving Spain, leaving thousands of bars, clubs, restaurants and nightclubs unoccupied. I would suggest that these are offered to Spanish Nationals or people who have been wronged like me.

In my case, Edward Thompson a major league Cocaine Trafficker, from the British Drug Mafia, already in prison serving a long sentence for 140 Kilos of Cocaine. He organised from prison with mobile phones to have my wife and I Kidnapped and Robbed. His son is still free doing the same thing and so are his crew members. I wish to discuss with the original judge in Edward Thompsons case information that they are not currently aware of and also verify some facts I have. I would like to look at the pictures of Edward Thompsons 7/8 men that were arrested with him to see if any of them were involved in the Kidnapping and Robbery of my wife and i.

Add to that total corruption in the Andalusia justice system with everyone in local government and justice being paid Bungs by the British Drugs Mafia, it's a totally corrupt system. So not only do we need to take out the British Drug Mafia but we also need to take out all corrupt officials taking money from these people and also subject them to the same RICO law and take all the assets of all corrupt people. This is the only way to stop it, along with long prison sentences.

I can provide the court with all the information on what is really going on to bring this about. All heads of the British Drug Mafia are Masons, they liaise with the National Crime Agency that are also completely infiltrated and corrupt and in some cases they are working with the British Drug Mafia and this can be proved. The Masons are controlling the drugs trade worldwide using this very system. Spain, with my case, can be the one that breaks them, handing Andalusia back to the Spanish.

They pay no taxes, destroy lives, ruin the future of Spanish children by taking away any possible opportunity for them in the Coastal Andalusia.

Gary Owens Media/Press Release: (The Ministry Of Justice Should facilitate this to get at the truth)

What I intend to say to the press is:

I want to know how the Spanish justice system can destroy my life, breaking its own laws with its legal representatives committing crimes to falsely imprison me and then destroy my life? If it were not for the fact that I was a public figure in the Heavy Rock business they would of got away with setting me up!

When i was arrested and first appeared in Marbella court in front of Dona Blanca (**please see Evidence Item 5**, writing of judge and possible finger prints) a clearly corrupt judge still working in the Spanish Justice system. She had a court functionary measure my feet, in open court, in front of everybody. She had all the carpets from the crime scene and there was footprints everywhere from the people that did the crime. I have size 40 or size 6 shoes, the people that committed the crime had much larger feet, she said in open court right then that i was not there and could not of been involved. I want anyone from that hearing to come forward including my interpreter! It would be useful if the court could help with this request.

I call for the police officer (studying to be a lawyer) from the Aresto Municipal Marbella who told me that judge Dona Blanca Esther Diaz and her husband police inspector Jimanez who was the chief investigating officer for the Marbella International Crime Squad part of Interpol (a miscarriage of justice in itself that they were married and also a point of inquiry as Interpol issued the EAW, who did that and we want every part of the paper trial relating to it), were planning to set me up for the crimes and the police officer did not agree or like it. He needs to come forward and speak the truth of what he knows, and explain in his own words why he let me escape from the Aresto Municipal in Marbella because he said they were setting me up. Also what exactly was said to him and by who. I ask this person to come forward for justice sake and expose this corrupt judge and her bent police husband, Spain deserves better. It would be useful if the court could help with this request.

I call for the Marbella Court number 4 functionary who was also imprisoned by the judge Dona Blanca to come forward and talk of how he knew the documents in my case were falsified by Dona Blanca and Inspector Jimanez. What else does he know about the goings on regarding this corrupt Judge and Senior Police official! It would be useful if the court could help with this request.

How can Dona Blanca be a Judge in Spain when we have proof she is a criminal? Who is covering this up? I call for her immediate dismissal from the justice system and her assets seized as compensation for what her and her husband have done to me. I would also call for all the justice system to be scrapped as not fit for purpose in its current form.

I call on the NCIS (National Criminal Intelligence Service)/MI6 Agent and the Norwegian Intelligence Agent who met me upon my release to come forward and explain where they got the information from that the person murdered was in fact a Norwegian Drug Trafficker, who was buying cocaine on the ta Del Sol and selling it through his night clubs in Norway.

Were they sent by Charles Formby from the Embassy? (**Evidence Item 4**) Charles Formby Writing & Fingerprint analysis, as i was already recruited to MI6 prior to leaving prison, as per my credentials established at the Royal Courts of Justice court hearings. (it can be verified by my Barrister Mark Summers).

I openly accuse the British Drug Mafia, the same British Drug Mafia that the British government don't want to admit exists. The same British Drug Mafia that uses Freemason lodges in Spain to co ordinate and run the British Drug Mafia. I call for all decent people to stand up with me and destroy them and the perversion and corruption that surrounds them. Along with the seizing of all their assets for the Spanish Crown and for the Victims of the British Drug Mafia.

All British Freemasons should be outlawed in Spain, they are sucking the life blood out of the economy of Spain. I appeal to the Holy Catholic Church (and I will be doing so in Rome) and the Spanish Monarchy to act and stop this lunacy.

I point out the Masons are in fact running the British Drugs Mafia and are the same people that stole my Intellectual Property Right worth \pounds 4 Billion in the UK that led to the false extradition. The same people who killed the person in my case.

It was either the British Drugs Mafia as I was instructed by Dona Blanca (Judge) who told me she knew who they were, and she showed the files to me, my wife and my mother who have already testified in the Royal Courts of Justice in the UK to this effect.

The only reason they are still alive is corruption, they are paying everyone. The British Drug Mafia and Masons are strangling the life out of Spain and have been doing for decades; I think the Spanish people should be aware of what's going on in their own country.

30 years ago when this started I saw Spanish people selling Maracas and bulls from bull fights on the beaches. Today the Nigerian Mafia have 15,000 people selling false goods up and down the coast taking 15,000 Spanish jobs and raping the Spanish economy of all the tax these people should pay. Denying Spanish citizens the right to work. Add to this local shop owners trying to sell real goods and paying their bills while the same fake products are being sold all over the Spanish beaches by a Mafia! And why? So bent police officials can line their pockets in backhanders to let them do it.

Spain needs to wake up! Just exactly how many of these 15,000 people are radical Islamic? It's an incredibly delicate situation supported by a corrupt system endangering everyone in Spain except the people stealing the Spanish workers money. Shame on you all for what has happened to me, and shame on you all for not acting when your country is being colonised by criminals.

I Call for the seizing of the British Drug Mafia and Freemason assets as compensation to me and others who have had their lives ruined by these illegal operations. Taking countless jobs away from the Spanish communities. I also call for all illegal goods being sold by so called "lucky lucky men", who could be from Boca Haram for all we know! To be removed from Spain.

I call for a public enquiry into how Spain can waste millions of Euros of tax payers money on a false extradition, and spend 30 years destroying our lives for a case that there is zero evidence for. In fact it was the opposite, there is 100% proof I was not there.

The case was dreamt up from the start by corrupt members of the Spanish justice system. I have had no legal representation at any point. I have had my human rights violated in all but two sections of the European Human Rights act, that's 34 four out of 36 articles of the Human Rights act have been broken in my case,

IT DOES NOT GET ANY CLEARER.

The Spanish and European Justice system has failed at every level, it's a total disgrace and not fit for purpose. I want compensating and I want some justice!

I demand a full review of funding for the justice system and security services, that has clearly been abused in my case and for corrupt reasons! If the Spanish government do not act and substantially over this matter, I fully intend to take the law into my own hands.

I will not live in a world where this sort of corruption is the norm! You're on official notice of my intention to act in any manner I see fit to take down the British Drugs Mafia and Masons in Spain along with any corrupt police and judicial and local government people that got involved in my case.

I want to be very clear, you arrest the British Drugs Mafia and the Masons or I will. If you force me to act I will take the whole country down if I have to. You're going to wake up and sort this out or I am going to make you!

I would ask the court to carefully study the attached document on corruption in the European Union completed by the European Union.

Crimes Committed In This Denucia:

Conspiracy to Murder and Attempted Murder:

Threat To Life Using Directed Energy Weapons (DEW) or Pulsed Microwave Beam.

Evidence of this threat to life can be obtained by the British Embassy and Foreign and Commonwealth Office that responded to my threat to life request twice. I was hospitalised because of it. I have witness statements from my mother in law, Patricia Fordham who contacted them regarding the threat to my life, and also a statement from my wife who also spoke with British Embassy and Foreign and Commonwealth Office, this has happened several times. They are available to be interviewed by the court on this issue.

They were firing DEW (Directed Energy Weapons, most likely pulsed microwave beam) at my heart, so i can feel it and then say kill him, and other comments via the MAE (Microwave Audio Effect) also known as V2k, (Voice To Skull, the explanation of how this works is provided in the legal pack). It caused me to collapse on two occasions and i was hospitalised.

DEW attacks on the heart are attempted murder, and, because it's planed and ongoing, that means its conspiracy to murder. It's also wreck-less endangerment to life. I want these charges enforced.

I filed a report with the Guardia Civil, but at that time i did not have the paperwork to explain the case, so they came to my home and made sure it was safe, and they watch my home at distance. I made the Denuncia on the 20th of July at 14.30pm they have this information on their computer system and i have had that confirmed at the Guardia Civil Barracks in Torrox Pueblo.

Car Fixing to Try and Murder Me

(As part of Conspiracy to Murder and Attempted Murder:)

They have also interfered with my car fixing the brakes and steering by watering down the liquid, i was told this by a mechanic called Paco that looked at it. The same mechanic on a different occasion told my tyre was deliberately knifed. All Gang Stalking related. Information on Gang Stalking can be found in the section **Gang Stalking:** Below.



This is Paco's Garage in Torrox Costa:

Interfering with the brakes and steering fluid is attempted murder, as i live in a very dangerous mountain area and they knew this. I discovered it when my steering did not respond right. I bought the car only one week before, it had brand new liquids put in. When i asked the garage man Paco to look at it a week later it was like water, Paco said it's been tampered with. You can speak to the mechanic concerned to confirm this, i have used them several times always because of the people Gang Stalking me and damaging my car.

On an occasion, one of the Gang Stalkers told me that, i should be careful as they could fix my brakes and try to kill me. He called it the Boston brakes (used by MI6 to assassinate people), when I'm driving along and they fail the breaks somehow, he said the military have done it to many people, he is ex military.

It was like a veiled threat. This man was called Chris Barrett, it's one of the reasons i had the fluid checked as it was feeling different, looser on corners and not responding right. He was clearly in the know about what was going on, and even if he warned me to help me or warned me to threaten me, i want him behind bars for at least complicity in the crime of trying to murder me.

I first met this man when he had my house under surveillance. I was watching him with binoculars, and he was watching my house with binoculars. I went up to meet him and he approached us and asked what i was doing, as i had binoculars like him. I said i was trying to see

who was living round my villa to put him off that i was on to him. He told me a lie about who lived in the houses, and i knew he was lying at the time as i knew the people i told him. More on Chris Barrett below in, **Criminal Damage To My Car:** section. Chris Barrett is one of the Gang Stalkers and should face charges of conspiracy to murder, Gang Stalking and torture, this carries a life sentence.

Electroencephalogram (EEG)

(As part of Conspiracy to Murder and Attempted Murder:)

Another thing they have been doing is using Electroencephalogram (EEG) projections using EEG mapping. What this does is send an electronic signal to my nervous system and they can make you do things like jerk your arm when I'm driving the car which they have done to me several times, it's like warning me, if i try to get justice they will try and kill me.

I want everyone who has used this EEG system arrested for conspiracy to commit murder, because that's exactly what it is. I have attached the documents that prove how this is done and it was done as early as 1979 by the security services in the USA and UK, including the Russian Woodpecker program also around the same time.

I have witnessed one local guy doing this to me twice, as i know how the technology works. It's the same guy later in the report that lives at a villa i marked on a map called 2828 fields in the **Criminal Damage To My Car**: section. This same man has been reported for stalking before, and it could be that he killed the guy who he was stalking, as he caught cancer suddenly and died, this is one of the things they can do with the technology they are using, like DEW Weapons, because over exposure causes these types of damage to the human body, evidence provided in the legal pack.

These signals for EEGs can be sent by duel band phones, phones can send EEGs and can be traced, as it has a special data train/form that is easy for a technical crime unit to find in the phone records. I can advise on how to do this, as i worked at top level in telecoms for some of the biggest companies in the world and understand data encapsulation at national security level completely.

I also know that all phone data transit packets have been recorded since 1996, which means everyone that has ever committed this crime can be caught using this method. As the Telco network Telefonica is controlled by British Telecom technically, i know where the data is stored for Spain. You must use this and clear up all these crimes and compensate all involved.

I would like all people that have been doing this in the area and perhaps the whole ta Del Sol arrested and imprisoned for Gang Stalking, Torture and Attempted Murder.

This EEG system is being used all over Spain along with other Gang Stalking techniques and electronic equipment such as Microwave Audio Effect (MAE). I have the names of over 1700 cases of people in Spain alone that are facing this same situation, they all deserve justice.

If you're going to solve the EEG crime for me it stands to common sense that you do it for your own citizens as well. Each case is a conspiracy to murder case, so that would make it extremely viable to prosecute. It's also organised crime, and as such falls under RICO law. This means the state can seize all the assets of the people involved, both for compensation to the aggrieved like me, as well as to the state for ts of the prosecutions and fines. I have also provided evidence of this in the legal pack.

In summary on the **Conspiracy to Murder and Attempted Murder**, charges, there is three charges of conspiracy to murder, the DEW Attacks, car tampering with steering and brakes, and using EEGs on me when i was driving making me move my arm unnaturally endangering my life, i want to file all three cases of attempted murder and conspiracy to murder.

Potential Murder Charges: Other people that could have been killed by these people:

Separate to this there is the case of Richard Fordham, he had all the same symptoms as i have, pain in his hands, choking on his food (full symptoms of the attacks listed below in **Torture, Sex Crimes and other Symptoms/Effects of DEW and EEG Attacks:**).

Unfortunately Mr Fordham had a weak heart, due to a heart attack 25 years ago. So when they fired the Microwave beam at his heart it killed him in the UK. He had many other symptoms of the Targeted Individual, and i have a recording of them admitting to killing him twice over voice to skull.

We believe that they targeted him because he offered to pay all my legal fees for the case i am still fighting. They (Masons, i know who) first removed him from the council in Scunthorpe in the UK and then killed him. They also held up his inheritance from his father's death with corrupt Mason lawyers. They killed him just before it arrived he died on 2nd of July 2016 and the money arrived on 30th 12 2016 after waiting two years Dicks dad died 15th Sept 2014. Also there was a dispute where lawyers tried to steal the inheritance and deliberately tried and succeeded to pay Dick and Pat less money, i want the Mason scum lawyers that did this investigated and imprisoned or we will have a big problem. All to pervert the course of justice and stop the crimes they have committed from being uncovered. I want them tracked down and charged with conspiracy to murder for this.

Also in another potential case the person who made a Denuncia of Stalking/Gang Stalking from the man at the 2828 Fields villa, in the section below, **Criminal Damage To My Car:** section. He suddenly got cancer and the people that were staying there were driven away by the stalking. This needs serious consideration knowing the facts and the technology. Along with the fact that 2828 Fields was caught doing it to me twice. This man has been charged with stalking by the Guardia Civil before and is clearly involved in Gang Stalking.

Conspiracy to Pervert the Course of Justice:

UK Court Case

My UK court cases are being stopped from going ahead by corrupt UK police that are Masons, the same ones that set up the false extradition so i could not sue them for £4 billion. They also duped the Spanish government into millions in legal its and compensation. They need bringing to trial in Spain for the fraud of Spanish tax payers money, as well as my money. For false extradition and conspiracy to pervert the course of justice, in my case, and against the Spanish crown.

I wrote a letter to my MP that started the false extradition preceding; the letter is in the legal pack, and is in the EU court system from the Royal Courts of Justice hearings re the extradition.

Registered Recorded Mail Theft:

(as part of Conspiracy to Pervert the Course of Justice:)

They also stole my mail sent in Spain which i wish to file as a separate crime as it is to be pursued in the UK courts. Mail theft is covered further down in the Denuncia, i included it here because it is clearly perverting the course of justice. There were up to 14 letters stolen, every offence of mail theft is a 2 year prison sentence mandatory in the UK, i want all of them enforced against these people.

All the documents relating to the theft of our Mail are in the folder - **FCO Mail Theft Case** in the legal pack.

Email Interception and Theft:

(as part of Conspiracy to Pervert the Course of Justice:)

The Mason Gang Stalkers are withholding and interfering with all my communications. Intercepting my emails, many of my emails go missing, and i don't get many people contacting me back as they stop the emails from coming back to me. They have even done this with lawyers we have tried to contact, including the state appointed lawyer. Every offence of email tampering is a 2 year prison sentence; i want all of them enforced against these people.

The technical crimes unit can go though my mail logs and find out which lawyers and other people we wrote to for help got the emails, there are hundreds. The ones that never got the emails will soon mount up. Copies sent should be matched against emails received to see they have not been altered.

Listening To My Thoughts:

(as part of Conspiracy to Pervert the Course of Justice:)

The Gang Stalkers are using Microwave Auditory Effect (MAE), Voice to Skull (V2K) on me, so they can hear my thoughts and know what I'm going to do in advance, like speaking to a lawyer. I have all the technology information on this subject and expert witnesses. Even the people who designed the equipment for MI6, and NSA will testify. This is clearly conspiracy to pervert the course of justice. I can also demonstrate Microwave Auditory Effect (MAE), Voice to Skull (V2K) to the court.

Manipulation of the Press:

(as part of Conspiracy to Pervert the Course of Justice:)

They have spoken to newspapers that we were talking with and stopped articles from going in the paper this is also perverting the course of justice when you realise what the press release says. You then know why they want to stop, and it goes directly to perverting the course of justice.

We have sent this press release via electronic mail to El Mundo, El Pais and many other papers and none have got there, yet they are on my account, this needs checking out.

The Sur newspaper has been stopped from running the story by someone; we need to know who that is so we can file criminal and civil charges. The Editor that has clearly been stopped can come before a judge and say who spoke to her. She is called Rachel

Electronic Weapons Attack:

(as part of Conspiracy to Pervert the Course of Justice:)

Physical attacks so strong you can't think or drive while doing 120 KM per hour on the motorway. They also followed me when i went to the Tribunal Superior De Justicia De Andalucía, to file a case against a corrupt Spanish judge that i have proof committed criminal offences against me.

They used electronic weapons to make me so ill i nearly crashed my car and got so confused i could not find the court house. I still want to file this case now but need protection in order to do so. Plus this was also attempted Murder.

There are many more documents related to this case and i would like to file this case with a judge directly, both criminal case and civil case for compensation.

I wish to also take out a civil law suit against the judge Dona Blanca Diaz and her Husband Jimenez who is a corrupt police officer proven in front of him with a lawyer present and his wife the judge who agreed he broke the law.

I have been told i can sue them now by my lawyer, once the ruling from the Ministry of Justice comes through in my compensation claim. The case is old and complex. But it's clear they don't want me to get any justice, and it's clear that it's a conspiracy.

They are stopping me filling many criminal law cases here in Spain and in the UK and EU. They are also stopping me from filling civil lawsuits against every person involved over the last 30 years. These are in themselves criminal offences and the Spanish court is just as liable to the charges and we will be filling in the EU against Spain.

Conspiracy to pervert the course of justice carries a 12 to 18 year prison sentence for each instance and there are many. They did this against the Spanish Crown as well as against me, falsified an extradition to cover their crimes at the expense of the Spanish tax payers. Which is clear from the case sumario from Malaga Audencia Provincial 1a court attached.

Legal Interference:

(as part of Conspiracy to Pervert the Course of Justice:)

The Lawyers we spoke to in the Torrox area have been spoken to by people who we don't know, and they have been put off helping us and taking our case. This is conspiracy to pervert the course of justice. Just what pressure was applied to these people?

We want all the lawyers spoken to by a judge to find out who spoke to them and what was said.

We talked to a local lawyer in Torrox Pueblo, we wanted to know if she could find out anything.



On the 21st of April 2015 we asked a local lawyer who spoke English to try to find out what was going on in a case concerning me, that had been dragging on for twenty four years. I was extradited nine years ago as a matter of urgency, ting millions in ts to Spain and the UK. The case went all the way to the supreme court in the UK, they would not sit and hear it at the House of Lords, as it would be televised and the masons would be implicated and accused on TV, my case was the first case ever filed at the Supreme Court in the UK. Total corruption.

At the first meeting Marie seemed to be efficient and good at her job. I was recommended to this lawyer by our landlord Don Manuel Atencia Cuesta, a local business man and ex council member in Torrox Tel: 655840851. He also spoke to the Gardia Civil Brigade Commander when i made a Denuncia on 20th of July at 14.30pm. Manuel is a good person to talk to re what is going on in the general area as he knows all the people and my situation.

I gave Marie a Denuncias to translate on Tuesday 7th of April. At the meeting on the 21st of April, we were met with a cold reception at first, then as we started to explain to Maria what was going on and showed her documents, she started to change and became proactive. The Abogada phoned the Fiscals office in front of Jayne Owens and I.

She found the name of the lawyer that was supposed to be representing us from the Fiscals office, and spoke to the functionary of the Fiscal who told her that the case was a mess and had been sent back as there was no evidence.

The functionary actually told our lawyer that if we wait 18 months the case would be over and we can then claim compensation. This was a huge shock to us. The case is a complete fabrication from start to finish and no one wants to touch it. So far we have had 5 judges 5 courts and 4 fiscals, all have done nothing about our situation.

The Abagada Maria at the same meeting filed a Denuncia with the Poder Judicial in Madrid, against the Marbella court from 24 years earlier, this case was ruled in my favour and the case

was moved from Marbella, to the Dean Court, Audencia Provincial 1a in Malaga. Later ruled i was not involved, and this is the compensation claim that is with the Ministry of Justice for five million two hundred thousand Euros pending decision now.

This was done as one of the documents we had given her originally was a reply from the Poder Judicial that we had contacted by email but did not understand their reply to us, we did not understand what was in the Poder Judicial email, it was a request for us to file the case, so Marie filed a case for us.

While she was filing the case it failed several times, we believe this was someone interfering with her network, perhaps this could be tested in some way to see if that was true. She said it was not accepting my (Gary Owens) email, which made no sense, I have had the same email for 20 years. She eventually got it to go but with her email address on, we later got a favourable response.

She set an appointment for us with the state lawyer we had been appointed in the case, for the following day.

She also got us contact details for a lawyer we were looking to engage to represent us in this case. This was the lawyer who represented Julian Assange who was based in Madrid.

We had an appointment to see the court appointed lawyer for the 23rd April 2015. The Abogada said she knows nothing of the case and was very evasive and would not help us in any way.

This was because prior to the meeting we were kept waiting for one hour, with what we believe was a police officer in the reception with us. I recognised her as following me when i lived near Marbella and she was on a bus with me once also, but could not place where from, our lawyer was in a meeting with a Spanish man for one hour, we believe that they were listening to us trying to find out what we were going to do re the case. Judicial Mafia? Marbella Police? I want to look at all photographs of every Marbella police officer for the last 30 years and private investigators. I will identify her. The man could be identified by finding her.

The lawyers name was Rosario Gomez Bravo, Number Colegiado: 1033: Tel 952 82 39 64, Moviles 630156110 / 607540788, gomezabogada@terr.com, Jacinto Benavente, 11-planta 1- numero 4.

We asked if the lawyer would do several things and she would not do anything, it was shocking but frankly what we have come to expect of the Spanish justice system in Andalucía.

We asked her to change my bail conditions, a right to do, she would not. We asked if she would talk to the fiscal about me going to the UK to see my ill mother who is dying of cancer she would not do this, (i want her disbarred and charged and her assets seized) even though the British Embassy had wrote to them to tell them at the court.

We asked if she would set up a meeting with the fiscal she would not do that.

We also asked for police protection a right, she said no to everything.

I want her arrested and disbarred for criminal negligence and questioned about who the people were in the office when we arrived. She deliberately perverted the course of justice and clearly discussed it with the two Marbella police officers prior to the meeting, so it's a conspiracy of the Judicial Mafia just the same as it was 25 years earlier.

The lawyer from 24 years ago we had is at the same office (he was appointed without our knowledge), Manuel Novella Morales, he came in at the end of the case after i was in the UK and did not witness the corruption we saw. We did not trust him, and expressly asked the Marbella court that he would not be our lawyer, so they appointed his partner! We think this is extremely odd and corrupt and clearly another act of the Judicial Mafia, and a possible miscarriage of justice.

We feel sure that the court are corrupt (This was proven when the Poder Judicial ruled they could not hear the case due to abnormalities in the case, (the court papers had gone missing), since that they have closed the court number 4 Marbella and sacked the staff). We don't trust any person we have met in Spain regarding this case.

The lawyer the court appointed us is the partner of the one we had 24 years ago. They keep moving the case from one building to another and from different judges and fiscals, It's a game they are playing not a court case. So far the case has been at 5 court houses, 5 judges and 4 fiscals all appear to want to wash their hands of it.

While I was at the court signing in Torrox Pueblo one day, I was with what's called the Juez de Gardia, a stand in judge when the court is closed, so I started explaining the case to her and she advised us to make Denucias.

While I was talking with her the phone rang and she was asked questions about what I was saying to her, she said I was asking about a case from 1992 to whoever was on the other end of the phone.

The point here is, who can ring a judge and get them to tell them what they are doing? And why? It's clearly the police who are backed by the Judicial Mafia that the original judge Dona Blanca spoke of, and fell afoul of, no doubt driven on by the corrupt Mason cops from the UK saying they know something that they don't as there is no case, it's all totally corrupt! We are filing charges in the UK as soon as this is over in Spain.

I am currently with the largest in the world, Sony Publishing, i could make a large amount of money very quickly from music if i was not Gang Stalked by Masons and their drug dealer counterparts, and security services private army for the masons, i know of two lodge's in Spain that Masons run drug gangs from and i want them investigated as part of my case.

This is part of the Ring Fencing done by Masons, and as i am now with the biggest publisher in the world, my career would of been the same, had they not stole my business and Ring Fenced me to steal my IPR and over £2 Billion pounds in share holder value. This was done by MI5, MI6 and current or ex members, all of them were Masons.

I have had to turn down an opportunity recently from a famous blues player that wanted to get a music project going, and i wish to sue the Spanish and UK security services for millions of pounds over this also.

Stopped From Earning A Living:

(as part of Human Rights Breaches)

I have been stopped from earning a living which is a human rights breach. I want to bring Human Right charges for denial of work. This also leads directly to conspiracy to pervert the course of justice because, if we had money we would have a legal defence, and they are controlling our finances to stop us fighting back, therefore perverting the course of justice, as its planed it's also a conspiracy.

This has been done by just giving us enough to live on but no money to fight a case, I'm a top Search Engine Optimisation Expert and i can't even get a job in a market that has a desperate lack of people with my skill set. So we intend to sue the security services both on Spain and the UK for loss of earnings over 30 years and bring criminal charges against all involved, there is a long list of people who have been involved, we want them all investigating and have a huge amount of information and evidence in this area.

Please read the sections in the chronology of events for more details:

Threat To Life:

(as part of Human Rights Breaches)

A continual threat to life, is a threat to life if the threat is real or implied, the continuance nature of the threat make the person perceive the danger and cause stress that over time causes the persons health to get worse and their nerves to become raw. So then when they do shock you with the device it induces a wreck less endangerment to life situation.

In my case this was done on multiple levels:

I would be driving along and they would tell me they are going to kill me or say do it now and things like that and then somehow cause the car steering wheel to move, a clear threat to life as i live in the mountains and the roads are very dangerous. They have been using Electroencephalogram (EEG) projections using EEG mapping.

What this does is send an electronic signal to your nervous system and they can make you do things like jerk your arm when I'm driving the car. Which they have done to me several times, it's like warning me if i try to get justice they will try and kill me.

They would do the same regarding my heart and say they are going to kill me and discuss it to try and demeanour you, and then shock you in the heart, this again, weather meant to kill or not could kill a person at any time (as we believe happened in the case of Richard Fordham above) and so again is reckless endangerment to life.

Constantly having to watch your car because they tamper with it as per the evidence provided below, they got Chris Barrett to tell me they could kill me like that, and then fixed the steering and brakes in my car by diluting the fluid and altering the electronics.

The combination of these different events over time is extremely debilitating and clearly a Human Rights breach.

While i was in Fuengirola the electronic covert harassment started, i started to hear voices and caused a scene that caused two local police officers to come to my home. What had happened was i could hear people out in the street talking about me, but i now know it was the start of the V2k. Things that have been used against me just because i want justice and to cover up the crimes they committed against me.

Technical and Computer Crimes:

There are several possibilities of what could be going on, but the main thing is, i use an internet system that went direct to London via Satellite, Satellite Internet. You can see from the images in the folder that this is not the case, the route trace does not go to London, and this is imposable unless someone is intercepting the data.

They could be diverting my internet from my home to their screen and then sending it on to the ISP via a proxy server, i only use satellite communications, yet when i ran an IP route trace the signal went to a place in Spain and also Sweden.

They keep cutting off my internet when i am on Hotmail or my Paypal account to access my account, and other accounts, so they can look through the accounts while i think its offline, i have many images of this over a long time.

Blocked Phone Calls

(as part of Technical and Computer Crimes)

Blocked phone calls crimes, one night i called the police 20 times and they picked up every time and no one responded. Is it possible to check my phone records against the call logs on my phone?

When people try and call me they never get through, and when i call out the same happens, this happens every time we try and get help from a lawyer or something we need. This is one of the ways they are perverting the course of justice and also it's a telecommunications crime to do this.

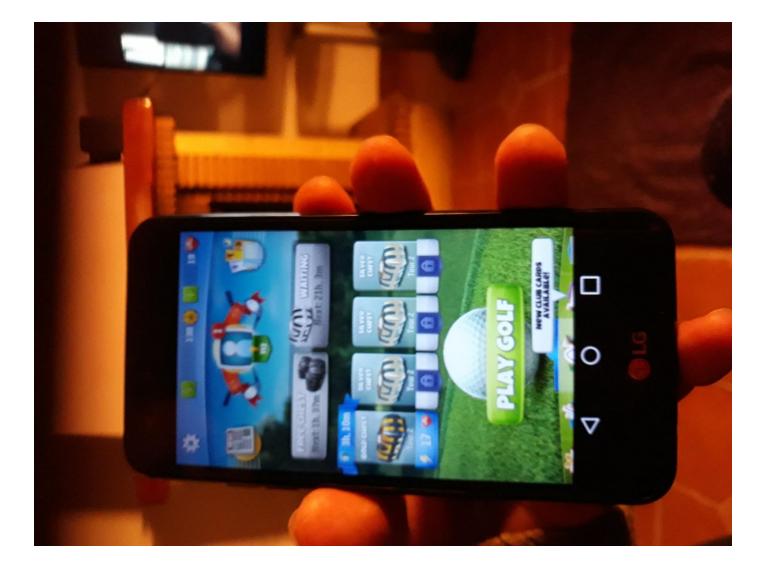
I think they are using a phone intercept cell these are readily available on the internet, you place it near the persons home and capture their call, and hear everything.

Hacked Phone

(as part of Technical and Computer Crimes)

We think all our phones are twinned and we need this checking.

Hacked phone, look at this image and you can see that its fed back through a different phone, the software is being pre viewed. You can see that on the image they sent through, that the resolution on the screen they were using, did not match mine and so it overlaps. This proves they are intercepting our calls and playing back information both from calls and internet, before we see it. This is also a crime.



Telecoms Forensic Analysis:

(as part of Technical and Computer Crimes)

We want the court to request all telecoms records for the Cortijos, Villas and Fincas within 5km of the Cortijo Mirra Sierra, our villa.

I ask the court to open a case and sequestrate all telephone and data movement records within sight of my villa in the last 9 years. Court requested acquisition of all call records from our surrounding area.

With the records from the year before i got there, you can see the changes clearly, nodes will appear where these people have been making mobile calls from, making it simple to check the right properties and talk with the right landlords and find out their Identification. Followed by questioning from the police of all villa owners and who have been renting their villas to these people.

I need Grupo de Delitos Tecnológi to go through my house, check the iptv system apps for cameras and microphones along with any software that is running on it, and also my tooway satellite system. Check past traffic provided by telecoms companies. Based on the images i have provided. By doing this against other local data movements we can find where it was being diverted too and by who. Both of which are telecommunications crimes as well as crimes against me.

For images i have saved from my PC of the same equipment showing multiple different ip

addresses over the last few years, yet i have had the same system all the time, please see the Folder in the Legal Pack:

Mail Theft:

I sent 14 letters to Spanish official and British officials, the letters that went to the UK were not delivered all were stolen from the secure hanger at Heathrow in London, we spoke to the Chief Executive's Office of the Royal Mail the British postal service and they advised us to file a case in Spain about the thefts. This was so that they could give us more information that they could not outside of a court.

So we are filing 5 charges of mail theft from the UK, pending an investigating in to the sixth letter that we believe was also not delivered.

We don't know if any of the Spanish letters were delivered we got no replies. We would like to check this out, and also file criminal charges for any that were not delivered, they include letters to:

I have provided all the copies of the Registered Mail deliver receipts and also the Correos documents when they paid us back the money for the letters being stolen. For each offence of mail theft carries a mandatory two year prison sentence. We would like all of them investigated and charges brought for theft of mail both in Spain and in the UK.

EU Microwave Emission Laws and Salud Publica

They are using equipment that is banned under European Law such as Microwave emissions law, and carries a heavy sentence. These weapons also have an extreme effect on a person's health, long term exposure to RF and Microwave radiation has a residual effect and i have provided

evidence the damage that can be caused to a person in the legal pack.

It can cause cancer and many other problems long term, as well as damage your nervous system i have already been hospitalised with the weapons, at the same time as i reported the attacks to the British Embassy.

I could not tell the hospital as i did not know how to explain it in Spanish and without all the evidence provided in this legal pack they would never understand. So i told them a lie just so i could get treatment. This hospitalisation should also be an attempted murder charge or grievous bodily harm charge. It is also clearly an abuse of the Spanish law, Salud Publica and could carry 4 years imprisonment for this offense along with huge fines. This has happened several times and i have needed to go to hospital many times but been stopped by the technology. I want everyone involved imprisoned for life.

It's clear that Electronic Harassment is contra to the Spanish law, Salud Publica.

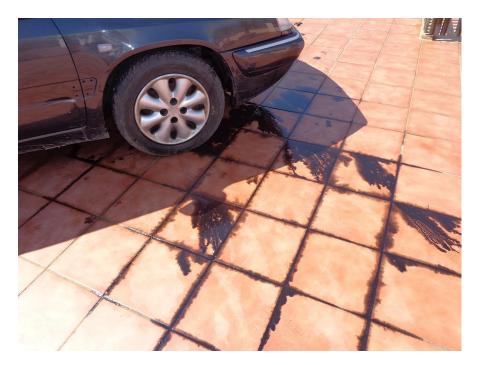
Criminal Damage To My Car

There have been several incidents at my home Cortijo Mirasierra involving damage to my car, they went to my car and drained liquid from the brakes and other damage that has been going on for years now, this image was under my car when i moved it one day, it clearly shows they took a washer or something off the car and drained liquid out. This was on my Seat Toledo 19tdi.





This is a different car and again it was tampered with over night.



On another occasion they have entered the car and pulled fuses out to stop electric windows in the middle of summer so i could not use the car.

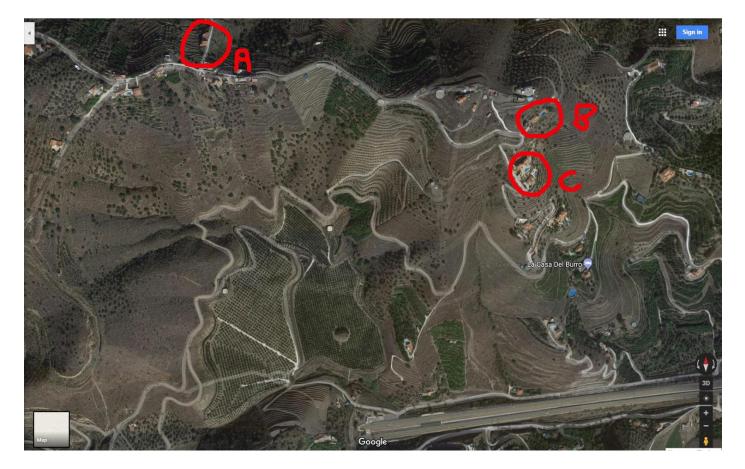

At point "A" is my address, at point "B" is the 2828 villa called Fields, and at "C" is the house that made a Denuncia about 2828 Fields owner for stalking and intimidation.

Another man who is involved locally is Chris Barrett (same person as involved in attempted murder above). This man has three cars here in Spain that are all false. They have no import documents and are on UK plates, i have been here 7 years and the cars have never gone back to England.

This is illegal, also he is somehow applying and getting false MOTs from the UK on the vehicles, this means that the he is committing fraud as well as invalidating his insurance. So if he has an accident in Spain he will not be covered.

His car is also fitted with a gas powered system that is illegal in Spain, he told me himself that he does not convert the car to Spanish because he can't due to the gas system being illegal and dangerous in Spanish heat, it's a bomb waiting for a hot day.

This man pays into the Padron, local community as a resident, yet his cars are here for years on end.

Because he pays the pardon he is tax liable in Spain, he is running a business from his villa and not paying tax in the UK or in Spain. This is also illegal, i think he should pay like everyone else, it's why Spain is in such a poor financial state, because these ex pat solder types think they can do what they want at the Spanish tax payers' expense.

As if this were not enough, he has made a large extension to his villa that he has no permission for, this is not right, everyone would like to do that, he just built it without local planning permission and by law it should be taken down or he pays a fine for the amount due around $\pounds 20,000$ in this case.

I was met by a SOCA (Serious Organised Crime Agency) Agent at the airport after waiting about an hour, he sat and had coffee and was fine, he got a call while I was there from some unknown (to me) person who told him that he did not expect me to be there, I was told by the SOCA Agent that if I did not go back to Spain they would not look for me and i would be safe.

But I wanted this over so I could sue the government's organisations and individuals involved who have stolen from me and committed numerous illegal acts against my family and i. In our UK case we will be asking for the person who rang Pete Murray's phone at the airport, and we will be filing a charge of perverting the course of justice as well as attempted murder for talking with their British Drug Mafia partners about my arrival in Spain in a deliberate attempt to have me killed.

A man and woman turned up from the Spanish side, we were talking for a bit over coffee, when the Spanish cop asked when I would be arriving as it was getting late, he thought I was a SOCA agent too. We boarded the plane, no handcuffs and no problems, got off the plane and went to some court in Madrid, again no problems and no handcuffs, that's where the niceties ended.

I went before a judge who remanded me to prison, and on the Friday the 13th of November 2009 I was sent to Madrid Soto Del Real, I was put in a module where not one person spoke English. It was a hard time as I had no cloths, money and could not speak to anyone. I was under threat all the time. Mental torture and cruelty is what it was.

A lawyer came to see me who was involved in my English extradition case, Leanne Balloto had spoken with to try and help us, but he was just a con man, he wanted £5,000 upfront and told me he would help me in the prison, to get moved to where others who spoke English were, he lied and did nothing, good job we did not pay him.

This corruption has always been the case with Spanish lawyers and still is now, in Spain there is no justice unless you have money, sadly this is the case throughout the EU.

I then got told I was to be moved to Malaga, I was moved from prison to prison, one day one prison, next day a different one, all the way down Spain locked in a steal room travelling for hours on end with no food or water and in unbearable cold. It took days, first night i was in a prison near Alicante, then moved to others I do not know the names, I arrived at Malaga having spent days in transit, not once was I allowed a hot shower, when I arrived at Malaga the water was off at the whole prison and I did not get a shower for 10 days, I was taken from Malaga prison after one day to the Marbella court in that state, unwashed for a week with no suitable cloths and i spoke no Spanish having not uttered a word for 20 years. I want whoever organised that imprisoned for mental cruelty and torture as well as deliberately disorientating me for my arrival at the crooked number 4 court Marbella.

On arrival at the court I was met by a translator and a lawyer who half spoke English, he told me to say that I did not want to change anything from the original court papers, I was in such a state I just agreed. I went in to the judge at court four Marbella, Avenida Arias de Velasco, this is not the court number four where the case was 25 years ago. This was also done deliberately so there was no reference to the corruption at that court building. The fiscal was present, the fiscal said he wanted 60,000 Euros bail, my lawyer laughed out loud, but the fiscal stuck to the figure, clearly negligent and corrupt and part of the Judicial Mafia, so I was taken back to Malaga prison.

At this point i want to dispel a myth the British Government likes to spin, that in the UK there is no Mafia, it's a total fabrication, the British Drug Mafia was around 30 years ago and it's the same people doing it now, they are a Mafia and as such fall under organised crime laws.

While on module 4 of Malaga prison where I was held, I met guys from the British Drugs Mafia, they ran the whole prison, I was told by the head guy called Ted (Edward Thompson) that he was the only person keeping me alive in there due to the fact that I was going to testify against others in their organisation. How did he know that? I have never spoke to anyone about the case, and these facts about the case like the murder weapon and other unreleased information has been trickling out, who is doing this? It could only be the people who stole my laptop the British Drug Mafia or the police, how could they have a copy of the case?

He was also told by National Crime Agents that I was extradited because I wrote a book called Humania on how to take over the UK & World which the Masons were worried about. The book can be downloaded from here http://humania.co.uk/about_us.html and its policy pages http://humania.co.uk/policy_page.html are also part of the book. So according to the British Drug Mafia I was extradited for writing a book on how to make the world a better place, they were told this by the National Crime Agency to cover up that they had stole my business and got Masons in NCA then SOCA to destroy my life and cover it up.

I was falsely imprisoned again in the UK and Spain, weeks of my life gone, my business and private life destroyed. I will be suing the law firms in the UK who represented me in the extradition case. I asked them at the beginning if they could just phone Marbella court and arrange for me to go and give me bail and i would just go back, they said don't do that. I will sue them for this, 7 weeks in prison and damages to my UK businesses along with the corrupt SOCA agent who committed perjury in the extradition hearing and got caught and the magistrate did nothing. We want to press criminal charges of conspiracy to pervert the course of justice and perjury against NCA.

We also wish to claim damages from the Spanish court for criminal negligence regarding the extradition papers and the eventual outcome document provided by the court that clearly proves criminal negligence. Just one point out of many, they said they did not know my name was Gary Owens and if they did i would not have been brought back to Spain. But this is a fabrication, as its all written out in the published extradition papers exactly what my name was and why it was changed and that extradition case was run by court number four Marbella according to the documents we have from the UK extradition. We would like this and every detail of every movement of every piece of paper time lining so we can see who is corrupt and arrest them.

Human rights breaches Art 5, 6, 7. In total 34 out of 36 Human Rights Articles were broken in my case against me. Length of time to trial, false imprisonment for two and a half years and the extradition time in prison. Two years awaiting extradition, 9 years since extradition and many other charges that if we ever got a lawyer who was not corrupt we would file immediately, but that's never likely to happen as we don't have 20,000 Euros to give to them to prove the Spanish justice system is systemic with corruption.

I also have proof now of the guys who stole the billion pound company VIP from me in the UK, used MI5 to steal my business and then ring fenced me so I can't take them to court and that's exactly what this whole case was dragged up for.

This all started with an MI6 agent called Anthony Keaton who was an undercover IRA operative, he had a private meeting with his brother who was my partner Ralph Keaton in an internet venture I was the CEO and Chairman. At the meeting he illegally disclosed information about my situation and security, these two guys are in the masons, same lodge, this is where the masons got involved and why they are also a legitimate target. The guys who stole my business that went on to be worth over 2 billion (I have the proof) were all masons and knew Ralph Keaton.

While in Malaga Prison After The Extradition

While spending time with Edward Thompson playing chess many times, we spoke at length about many subjects; one subject was the Malaga Prison football team. Ted (Edward Thompson) told me that he had a member of his organisation on the outside of the prison that sponsors the Malaga Prison football team shirts called Norman Hay.

Later while in Fuengirola I was approached by this man via a set up I was doing on the Masons to find out about how they were trafficking drugs through their lodges, the British Drug Mafia knew through surveillance I was doing, I did this to flush them out and I have a sequence of emails and documents related to this meeting, he is called Norman Hay he is one of the heads of the British Drug Mafia a major Cocaine player in Spain and is head of the Masons Lodge in Fuengirola. The whole lodge is full of traffickers, the guy that owns the Tucan bar on fish ally is a Knight of Malta Mason, fish ally is a notorious drug dealing place, another member owns aroma on fish ally this

guy also runs the biggest night club in Fuengirola and sell drugs organised through his mason friends. The same is going on in northern Spain where Kevin Concannon and Chris Fairfax are head of another Masons lodge, Kevin was caught with seven tons of marijuana and go 14 years. He's head of another lodge, the story is the same all over Spain.

Ted was protected all the time in prison by a guy called Gary Jacks, who wore a number 1 cap all the time signifying he was the enforcer, and he was. I spent many hours talking with him, he is a real hit man for the British Drug Mafia. He was in prison for attempting to kill his wife, whose maiden name was Appleton. While he was in prison he hired a guy in prison who was from London to Gang Stalk his wife in the UK called Paul Clarke, they smashed her windows and did all the things that Gang Stalkers do.

He paid him £20,000 to destroy her life. When I was out of prison later and went up to Mark Warrington's (British Drug Mafia 07709088013) house in Coin he insisted on going to watch her where she lived now, he was obsessed with trying to kill her something to do with his horses that were sold off and his dog.

While I was in prison the person I was in a cell with was on Britain's Most Wanted top ten list and no one knew, I found out when I was out and told Wensley Clarkson the reporter, it was a front page story and he never did anything.

Papers in the UK would of paid thousands for the story.

He told me the Daily Mirror would pay me £3000 pounds for the story. So we need to find out who Wensley Clarkson is and why he would not report a top 10 wanted criminal, more than a strange thing to do!

He was called Justin (Mother in UK 02392614794) and was handed the Number One cap when Gary Jacks got bail clearly showing he was with the British Drug Mafia. He was an ex paratrooper in the UK military, i know this because i did the same training in the same place as him. He knew things only a solder would know about the training. He teamed up with Josh White and Paul Clarke well known London drug traffickers and part of the British Drug Mafia.

Justin was ex 2nd Para a unit I have worked with, he was not lying about being a paratrooper but he could of been undercover MI6 and that's why they would not blow his cover. I can't think of any other reason why they would not expose him. It would be worth looking into his background.

On the last day before I got out Ted offered me a place to stay (he has a lot of places and is wealthy, he got caught with 140 kilos of cocaine). I took the offer as I had no money and no where to stay, I stayed there for about a month, it ended badly, I guess I should of known but I had nowhere else to go. Statements from my wife done at the time are enclosed, are also witnesses and a video.

Regarding getting released from Malaga prison it turned out my supposed lawyer was a personal friend of the fiscal. I appealed the decision and they lowered the bail to 6,000 Euros it took my family a while to get the money together, so I eventually got out on the 7th of January 2010, with no money, no passport, no ID and no address to live at! What a crazy state of affairs.

On my first day out of prison I stayed in a hotel in Fuengirola, I walked out of the hotel and found an Indian restaurant totally at random, within 5 minutes a man came into the restaurant and sat down and was talking loud about SEO and websites. I spoke to him about it as I was an expert, he offered me a job but I was about to live in Selwo near Estapona so I turned him down.

This man was Tony Muldoon (607606273) a well know British Drug Mafia guy and con man and was running every scam you could imagine from some office in Fuengirola. Later on when I returned to Fuengirola he approached me again, they were clearly trying to get into me.

On the day that I went down to his offices I noticed a man I knew Tony Seville (0034697377333), he said he was renting an office there from Tony Muldoon. I had been working in the same office as him for ta Property Shop, the whole place was a Europol office. The following day, Tony Muldoon was arrested and his whole operation was shut down and he went off to the UK on extradition and got 6 years. This clearly shows that the National Crime Agency were watching me.

While in Prison someone I knew from 30 years ago at Ronnie Knights (London Mafia) bar was in for Drugs Trafficking, I knew him as head of the Del Sol Moroccan Mafia. I asked him if they were still doing it on the port re bringing in Hashish from over the water, he said yes but it's become so expensive that it's almost not worth doing.

He explained that he moved 400kg of hash down to the coast from Alhaurin where it was stored in a villa, the people that were to buy it looked at it and did not like it. He said they had planted a tracking device on his car and the next day when he left the property they broke in and took one ton of hash from his garage.

He said between this and having to pay the Fuengirola Guardia Civil £50,000 per load and the same over in Morocco to his own police, plus the transport and people involved, he said they were all thinking about stopping it as it had become too dangerous with the appearance of eastern European Mafia all trying to steal their product and the police taking so much money.

He said it's not like the old days, he paid money into my account in prison and gave me everything I needed to get along in jail. I have his details and would provide them only to the judge in the case.



Tony Muldoon with the British Drug Mafia also owned a boat business in Fuengirola harbour where they bring in tons of Hashish from Morocco with the help of corrupt Guardia Civil who are paid £50,000 for each delivery.

The deal is, for the bung/money, they have to secure the shipment until it is away from the port with no one watching. The person who told me this was not Muldoon, I just went to see him as I knew they were doing it, i always investigate drug mafia.



The Spanish head of the Moroccan Mafia gave me the information; he's the person who actually pays the Guardia and the Moroccan Police get a similar deal for it to leave there shores.

This has been the method with the British Drug Mafia since Ronnie Knight was running the drugs trade in Spain from Knight Bar in Fuengirola, the same guys that are doing it now are the same people from then, this is why it's a Mafia.

Carrying on a criminal enterprise is the

very definition of a Mafia, there is a mountain of evidence to prove this. And no excuses will be acceptable other than an agreement by the Spanish Authorities, it's going to end right now! Along with all their assets being seized under RICO law.

They were fronting the boat business from Tony's Office on the port in Fuengirola Port Ticket, called Marbella Heat SL:

This also included owning charter boats that did the pickups as well as having fishing boats on the other side of the sports port. They ran drugs into Fuengirola using this charter company, I spoke with Dean (boat captain) myself with Tony Muldoon present.

I asked him straight out, so you're the guy that brings that great gear in, he said shush, and smiled, and sat down with us, Tony suspected me at that point but to me he was only a mark to take down.

The charter shut right after Muldoon was arrested, I went and spoke to Dean again and asked him what he knew about the Muldoon arrest, he said all he knew is that Tony was in Malaga to be extradited to the UK. He told me he had to close his charter because of it, and was very worried, I wonder why!

What the British Drug Mafia do, just like all criminals and the NCA in the UK also do this, they change the name and carry on just like normal, if you go to the Dean fishing charter twitter account you can now see that the name has been redirected to their new game. Change the name the game is the same; they will now be bringing in drugs using the new charter system.

Back to my release:

I contacted the lawyer who had represented me in Marbella and he said he could not represent me any more without payment, he has since not responded to several emails, his name is, Juan Antonio Urbaneja Guerrero, 00 34 952 785 793. I want the relationship between this lawyer and the fiscal investigated, for example were they Masons? Are they in the Judicial Mafia? What communications went between them at that time? All judges and fiscals involved in this case and anyone who had any say in documentation needs investigating re the British Drug Mafia and its clear links to the Masons.

As I was leaving Malaga prison the conditions of my release were that I had no passport, but the prison gave me the passport in my hand, actually I have two, one with the court that I gave them later and they returned but out of date and no good for travel and another even older one, both are out of date but they did not know that. I have been told that they wanted me to disappear so they did not have to deal with the case. So they gave me the passport so i could leave Spain against the orders of the court, who can arrange that?

I had to sign at the court every 1st and 15th of the month which I have from then until the case ended, which is a human rights breach and the responsibility of the state appointed lawyer we had who would not put in the request, we want her disbarred and arrested for criminal negligence and we intend to sue her practice for \pounds 100,000 for this alone.

Just before Christmas 2011 a court official asked me not to come and sign anymore, he said I did not have to, his name was Luis (Marbella) he's a guy, his number is 00 34 951 975 328, he said the case was over, I pushed him on the point, pointing out that if I did not have to sign and it was over I want my 6,000 Euros bail money back. You need to ask yourself was this an attempt to make me go away at this point! Or get me not to sign for some strange corrupt reason. Either way it needs investigating. He called the court in Malaga Audencia Provincial, seccion 1, tel 00 34 952 823 964. They said they have never heard of the case and have no documents relating to the case. It took over a month to find this out.

Luis (off his own back) then made up a separate case pack and sent it to the Audencia Provincial and gave me a copy of the Currier form to prove to me that this had happened, I signed the papers on the back page before they went, but I have no idea what it was I signed.

Another Spanish court joke system. This all needs investigating, if it was not for me the case would never have been dealt with which is exactly what the corrupt Judicial Mafia wanted in the first place, as they are liable for the crimes they have committed and want to keep it covered up.

I then had Prisoners Abroad contact them, a well known organisation helping UK prisoners, a lady called Elena Gonzalaz from PA Tel: 020 7561 6820, private line 020 7561 6861, she said that they are now aware of the case, but I have no information about the case and no lawyer.

The situation at this time was that we had no money (Jayne's parents got a loan out before Christmas that year so we could survive) and we were under constant threat from local British Drug Mafia guys.

Our phone was and is bugged and every email we send is intercepted, we have to go to a Cyber café just to get one through. It is clear that this is perverting the course of justice, and has been all the time, the idea being that if I have no money and no one to back me up they can manipulate the court decision and stop the information coming out.

We want charges of perverting the course of justice brought against all justice workers and police involved in the case, court functionaries, judges, fiscals and all security services involved, anyone who had anything to do with the case. We also wish to sue every person through the courts following the investigation.

As far as I am concerned the British authorities/establishment has committed an act of treason against me. They have endangered me and my family and put all of us through mental torture, victimisation, Gang Stalking, breaking the law over and over against me and no one wants to help. All for greed! I will be taking legal action in the UK following this Denuncia submission to the court.

Time Line of Events

Each section below has an email log in chronological order, with evidential information, available to access on request from the courts judicial investigators. Plus i have an evidence pack including many people's fingerprints to verify their Identification.

Selwo National Park

While living at Terraces Del Sol, 45E, Urb, Terrazas Del Sol, 29680 Estapona, Malaga, a British Drug Mafia embargoed property belonging to Edward Thompson, who let me use the property, as per the Kidnapping & Robbery Statements below. Later we found out it was embargoed, and then the British Drug Mafia had my wife and I Kidnapped at gunpoint to steel our son's computer so they could find out what we knew and pervert the course of justice.

There was a knock at the door I open it, two guys burst through one huge guy wearing a motorbike helmet and another guy, they had a gun, they made me get all my stuff and leave right then with nowhere to go. There whole aim was to get the info on the case. They stole my son's laptop with all the details of the case on, and took all our phones off us, they just wanted to find

out about the case and who was implicated and who we had been calling. All they really wanted was the case files, who were they for?

Jayne was with me at the time, we have written everything down relating to this, at the time it occurred, in the attached statements. There are other witnesses to verify this happened, we spoke at length to the Terraces Del Sol Administrator who had a video of them arriving and the whole thing, and it had many security cameras. This man should also speak with the judge in the case. He advised us of where the Estapona police were and told us he knew of many goings on in Ted's British Drug Mafia Penthouse apartment, he could prove very lucrative as a witness.

Statements Below: We expect all the people mentioned in these statements arrested and imprisoned and we wish to apply for compensation against their estates which should be embargoed under the proceeds of crime laws and RICO relating to organised crime.

Kidnapping & Robbery Statement

This is the Statement By Gary Owens regarding the kidnapping and robbery at gunpoint by Edward Thompson, Edward Thompson Junior, Gary Jacks and others, Denuncia.

When I first got to Malaga prison and got on to module 4, I could sense that I was in danger, a guy called Edward Thompson, nickname Ted, told me that he was the only person keeping me alive, and he referred to me being a grass, as did my cell mate, so I knew everyone knew before I even got to the prison.

Ted was running module 4, bringing in all the drugs and mobile phones, he is still running drugs outside using mobile phones to communicate and he recruits people inside that are getting out to help him.

When I got bail Ted offered me an apartment cheap and as he had protected me in the jail I thought it would be OK, I also did not know anyone on the coast and did not have enough money to pay for a new rental with the deposit.

Ted told me that it was six hundred per month and that I did not have to pay a deposit, he gave me a number to phone of a lady (his wife) called Hakima, to sort out the details of the apartment, I called her an arranged to meet her in San Pedro, she turned up with a man who I had seen in prison who sat with Ted every day called Gary Jacks, Gary was in the same cell as Ted and acted as a body guard, he was in prison for murder and had told several people including me that he was a hit man.

Gary and Hakima then took myself and Jayne up to the apartment 45 block E, Terrazas Del Sol, Estepona, Malaga, 29680. We said we would take the apartment and agreed to meet with Gary the next day and give him the money six hundred pounds, when we moved in we realized that there was no water on and it took nearly a week to get it put it on, the apartment was in a mess, every socket in the place had been removed, it had been systematically searched by someone, I conducted my own search and found 8 ecstasy tablets tied up in a durex down the side of the settee and flushed them down the loo, I was already regretting moving in and text Ted to tell him of my dismay!

I got no reply, so I contacted Gary who was receiving calls from Ted none stop and doing things for him, I met Gary at Puerto Banus and while I was with him Ted called so I ask Ted for a months free rent for the state of the apartment and the problems we had had and also that after the months rent free I would only be willing to pay four hundred a month due to the state of the apartment, I said it was either that or I would have to move out.

Ted agreed to what I asked and told Gary, Gary confirmed this with me and Jayne later.

I had decided to look for a new place to live away from Teds place, so I could get on the internet, and found a place and paid the money in advance, the day before I moved the bell rang on the door of the apartment, I looked through the spy hole and it was Hakima, so I opened the door, as soon as I did two big guys rushed in from round the corner one wearing a motorbike helmet and body armour, they started shouting at us saying that we owed them money, one thousand Euros, we had no money and we did not owe them any money, we did not even know who they were, Hakima left the apartment, they held us there and made phone calls to someone and received phone calls, we were both terrified, they said they wanted the laptop and also took our phones, I said to them if they took the laptop I would go to the Police, they were being very intimidating and shouting at us, they said they would shoot me if I went to the police, the blond guy with shoulder length hair and a London accent said he would put a bullet in my nut if I contacted the police.

The blond guy instructed the guy with the helmet on to show me his gun which had a black handle, semi automatic type gun. The guy with the helmet on threatened to tie us up if we did not cooperate and the blond guy told us that the helmet guy was wanted by the police and that they had both been in jail.

After holding us against our will for a while and intimidating us, they told us to pack all our stuff and leave the apartment, we did this and they took the keys off us and the laptop and phones. When I went out on the balcony I saw Hakima waiting below in an X5 silver BMW estate car, with what looked like Teds son, the two men went down and got in a small silver car and followed Hakima out of the complex and left us there.

All the time we were in the apartment the men were receiving instructions from someone by phone.

I believe that they only came to get the lap top because they were aware that my case files were on it and that it implicated members of the British drugs mafia and also named SOCA agents who could also be in danger. They never asked us to empty our pockets or look at my wallet or any thing else to get money this is why we believe they just wanted the laptop.

Now they have this information its proof that I have given information to the police and they will use this to try and have me killed, I am in grave danger and need help.

While the two guys were in the apartment they named Gary Jacks and said we could get the laptop back of him if we paid 1000 Euros which they know we don't have and don't owe, we contacted Gary and he says he knows nothing about it but that can't be true because they used and gave us information that only he could have known.

Kidnapping & Robbery Statement

This is the Statement By Jayne Owens regarding the kidnapping and robbery at gunpoint by Edward Thompson, Edward Thompson Junior, Gary Jacks and others, Denuncia.

On Sunday the 7th March 2010 I am not sure of the exact time but it was after 12oclock (afternoon) probably nearer to 1/130pm. I was upstairs making the beds and cleaning round when I heard the doorbell go. I could hear Gary walking to the door to open it. I heard the door shut and footsteps walking into the apartment I then heard male voices talking very aggressively demanding money from Gary. I stood at the top of the stairs at first to try and catch what was going on. I heard this man's voice saying you owe me a 1000euros and I fucking want it now.

I then slowly came down stairs this is where I saw two men of whom I had never seen before. One stood over Gary (Gary was sat on a chair and the man was stood over him very close) shouting and swearing at him demanding this money saying that the apartment we were in was his and he wanted his money This man was blonde with shoulder length hair which was swept back off his face he had a London accent I think he was age mid to late 30's in not sure on that its difficult to say. I would say he was about 5ft 10 approximately of average build. Then there was the other man slightly shorter in height and stocky I could not see his face as he had a crash helmet on Blue in colour he came across very menacing he didn't say much really but his body language said it all he was stood with his legs astride and swaying from side to side. I found him very intimidating and very edge

When they saw me they said sit down I was very scared by this time but said no I won't the blonde guy said if you don't sit down well tie you up and the guy in the helmet then said sit down and stepped towards me. I still didn't sit down. I looked at the guy in the helmet and said if you're trying to scare me you doing a good job well done. Why the helmet in the house? The blonde replied there are cameras everywhere and he's wanted. Don't know if that was true or just for effect.

The blonde guy kept going on to Gary about how he had lied to Ted (this is the man we knew who owed the apartment but the blonde guy kept saying he owned the apartment he just let Ted rent it to Gary. He just kept going on intimidating both of us asking for the money and saying he wants us out right now and if we have not got the money to give him right now he will be taking our laptop and anything else of worth. We tried to explain that if he took the lap top Gary couldn't earn any money he works on the Internet but he wasn't interested he said he would be taking it if we didn't give him the money owed. I said if you take the laptop (which isn't ours it's my dad's) I would call the police in which he replied and lent over Gary right up to his face if you call the police I'll put a bullet in your nut. By this time I was in tears. He looked at me and said go up stairs and start packing g and told the guy to follow me, which I did.

He followed me up while I was packing he went down again and they just kept going on about Gary lying to Ted and they want the laptop etc. I was worried about what they would do so I slowly came back down the stairs, as I did I heard Gary say you don't have to show me that. Meaning a gun I know he meant this because I saw the guy with the helmet putting it back in his jacket as I came down. They asked if I'd packed I said not yet I'm here I am worried about what you're going to do. The blonde guy replied it's lucky for Gary that a girl was here or it would be much worse for him. They implied that they knew I was in the apartment before they came which I found quite strange at the time because I had only arrived on Friday the 5th and there was only one other person in Spain other than Gary knew I was there and that was a guy called Gary (Tig) This guy knew as my Gary had told him because we owed him some money which I had brought over for him and we had called him the day before to let him know we had it and to arrange a time to meet him. WE had called him on the Friday when I arrived and arranged to meet on the Saturday but the weather was so bad we all cancelled and said we would make it another day.

The reason I mention this Gary (Tig) is the Blonde Guy mentioned him when saying about us owing money because he stated that we owed this Gary money too and he knew exactly how much we owed to the euro. He also told us when we had their 1000euros we where to ring Gary and he would arrange for us to get it back.

While all this was going on the blonde guy made and received several phone calls to a woman I think they were down stairs waiting because he kept telling then what was going on and how long he thought they'd be. I knew it was a woman as I could hear the voice it sounded like Hakima (this is the wife of Ted).

They made us pack all our things following us everywhere I was a complete wreck by now my whole body was shaking I kept pleading with them not to do this but they would not listen. They made Gary pack up the laptop, which he had been working on then made us give them all our phones, which there was three one, Spanish and two U.K one. All the time this was happening they kept going on about Gary lying and how we would get our things back when we give them the money. They also said at some point how the last guy who had done this to then had been found and sorted out.

Because of all the things this guy was saying was untrue about us owing money etc I think he had not been told the truth because the arrangement Gary had with Ted had left us where we owed him nothing the time was ending and we were in process of moving out so no one was owed anything. This had all been arranged and agreed with Ted over the phone about the finances etc Gary had spoke to Ted at length on a mobile phone in Puerto Banus while Gary (Tig) was sat with him.

When we had finished packing they forced us out of the front door taking our things which where a blue dell laptop a silver hard drive with music on and our 3 mobile phones. Luckily I was not wearing any jewellery at the time or they would have taken that too. It did seem to me the money thing was not what they were after but the laptop because they took our word for it that we had no money and never once made us empty our pockets they just wanted the laptop it seemed. They left us stood in the hall of the apartment block when I looked over the balcony I could see a silver bmw 4x4 type car, which I recognised, as belonging to Hakima They left in this car.

Edward Thompsons Sons phone (615730439) Edward Thompsons phone in prison (633404955) Hakima, Edward Thompson wife and Moroccan Drug Mafia (she's the daughter of a Moroccan mafia drug kingpin), (636806381, 697852857, 600258156) Gary Jacks (Known as Tig, 659149096, 633353238), Paul Clark British Drug Mafia, (633262061, 678943481, 00447838446175, 004479405590014, 0044784422874), Josh White (London Mafia), Mark Warrington British Drug Mafia and his girlfriend Satu from Finland.

Top 10 wanted UK man Justin British Drug Mafia, 76 Butterfly Drive, Paulsgrove, Portsmouth, P06 4DL (ID can be checked via Malaga Prison Governor at the same time and in the same cell as me)

As part of the theft and kidnapping they also would not let us go in the apartment again, so we had nowhere to live Jayne went back to England.

I had been frequenting a local bar the owner was called Eduardo (Edu, 627188719), since I was falsely imprisoned 30 years ago I have smoked Marijuana and I used to get it from this bar from

Eduardo who would get others he knew to fetch it. They were British Drug Mafia who delivered it, Edward Thompson was their boss in the British Drug Mafia, this is the same area Edward was arrested in for 140 Kilos of Cocaine.

I met a man called Tim Kemple (he had this Wifi card, wlan_e3 x000138fee6e3 and these phone numbers 630313542) with a woman called Annie (622112746) who was Scandinavia in the bar, Annie was living in a secure compound so I assume she was Europol. He was sharing an apartment with Humberto Sanchez in Terraces Del Sol in a different block. I was suspicious of both Tim and Humberto being either in the drugs trade or they were police. It needs looking into.

Tim worked for a company called ta Property Shop he got me my first website job in Spain that turned out to pay me over £22,000 for a site that never went live owned by Philip Murphy (691661922), this is and has been typical of the Gang Stalking and Ring-fencing done by Masons using National Crime Agency agents and the British Drugs Mafia against Targeted Individuals.

The people, who stole my IPR and use the British Drug Mafia to do the Stalking, know they have done wrong so they pay me and stop me from telling anyone about what's gone on in the UK regarding the theft of my business and IPR (Intellectual Property Rights) worth billions of pounds. Also they don't want me to talk about my work for MI6 and the National Criminal Intelligence Agency where I had access to all top secret information for the Masons, Monarchy and Government, including all communications over a 12 year period.

At this office I met Juliet Hambro (616241614) she messed me about and was spoken to she should be questioned to find out who?



I was asked by the owner to do some work, he took me to an office in a Marbella 5 star hotel Gvadalpin where we met lots of people in an office, clearly all Masons. They were selling apartments in Turkey and other places, they basically messed me about as did the guy who took me there and was a Mason. While I was at his office Annie walked in, she was pretending to want some work done, but she was just trying to see what I was doing, she and Tim need investigating.

When I left prison I was asked by one of the inmates Mark Warrington a member of the British Drug Mafia to do him a favour, I was to meet his wife and she would provide me with a car a land rover in turn for sorting out several issues he had which turned out to be stolen cars.

So I did nothing. His wife started hanging around me she was called Satu (663261475, 08717710666, 663261475) She kept going and reporting to the London Mafia members son of brinks matt robber Josh White (646659504 mother Margaret), caught with 3 tonnes of Marijuana out on bail. The man that Gary Jacks paid £20,000 to have his ex wife Gang Stalked is Paul Clark British Drug Mafia now living in Amsterdam, he told me Gary had asked him to do despicable things to his wife in London and other places in an ongoing campaign.

At this point I managed to get a local man called Umberto Sanchez to put me up who was also living at Terraces Del Sol

I was never sure who Humberto was, he claimed to be an estate agent, but one night drunk he told me he once smuggled cocaine across the Mexican USA boarder in a camera, where he used his drug money to fund his real estate licence and then come to Spain to do real estate.

Several things did not add up with Humberto, for example, after Teds British Drug Mafia crew Kidnapped us at gunpoint, Humberto drove me to San Pedro out of the blue, and parked right in front of Ted's wife's apartment while he went to fixed his watches in a local shop, so the British Drug Mafia had already got to Humberto, or was it the National Crime Agency trying to cover their asses re the false extradition and the theft charges and disrepute it was going to bring on the Masons when it was uncovered.

They were a brief for our lawyer Luis Tatay and have some very revealing information about how Marbella court falsified the extradition, with clear collusion from the UK authorities.

I moved to a new flat with Humberto, I had no choice, Jardines del Albaicin in Belair, Marbella, we were followed there and we started to get intimidated by the British Drug Mafia.

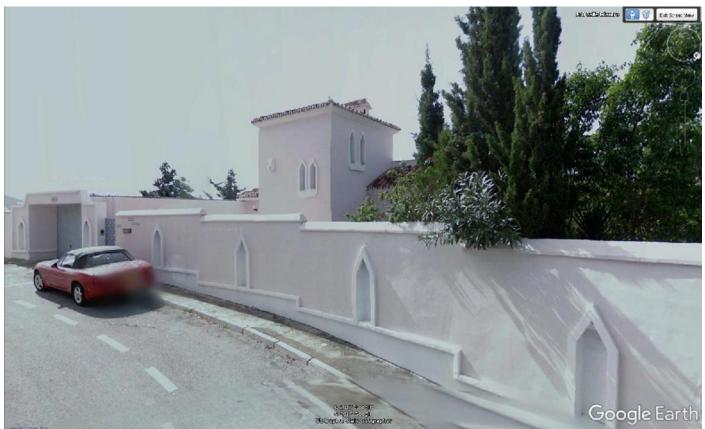

While I was at this property I was sat in a bar just up the road from the villa and a man sat next to me lent over to me and said be careful there is an MI5 agent in the bar, I said who is it, he said it's me don't you recognise me? I did not, he said he was the operations director of cable and wireless Paul Cullumbine (pcullumbine01@btinternet.com) and was present at a meeting I had with David Wickham Managing Director of Cable & Wireless when they gave me £10,000,000 pounds to help the roll out of my company. Details of this meeting are in the Legal Pack.

I think the person is real, but this whole thing looks like an MI5 control so I can't sue them, or to keep a back channel open to find out what is coming up re the legal case for theft of my business in the UK who MI5 are clearly involved in, and try and stop it.

I have a signed confidentiality agreement with Paul that gives his address as 4 Lichfield Road, Abbots, Bromley Staffs, WS15 3DY. The document could be used to get his fingerprint ID and confirm who he is.

He has expressed an interest in working with me at top level but because of the Gang Stalking and Government interference trying to stop me from suing them, it is impossible and so I will be suing the parties involved for this denial of work and bring criminal charges in the UK against the various parties on Human Rights grounds in the Royal courts of justice and the EU and UN courts. Along with various select committees on security services oversight.



He is still in touch with me and still an MI5 agent working for major corporations like they do. The night we met he had his whole family with him and they are witnesses to what was said at our private meeting at his villa. We discussed the whole situation and he said everyone in the service knows you are telling the truth and I know because I was there. In exactly the same bar that I met the MI5 agent Paul Cullumbine and the first so called business guy to come into me in Arroyo de la Miel was a Scandinavian guy, I called him "B" for Bernard, he was in the bar the night I met Paul first. I later found out his name was Berell. (662686257)

He was pretending to sell energy, I did him a few websites all were not used, as is the case normally in ring-fencing. He was not a business man but pretended to me to be a senior figure in a company, he could not have been, he had no business acumen at all, and he was Drug Mafia or an Agent from Europol.

He kept meeting me in out of the way places like "Baboo, it's the clubhouse restaurant on the golf course next. In one place I took him, once we knew who he was, we were sat outside a bar and a black VW car pulled up and the people in the car were looking at me him and Jayne, I pretended I did not see it, he turned to me and said, can't believe you did not see that, I said what.

I stared him out and his mouth went dry and he said audibly I need help, he knew it was up and he was asking for help via a microphone, his wife showed up within 30 seconds, but that was the relationship over. At around the same time I started to get work from Ashley Varley who ran a sex website called sensationalsextoys.co.uk, my guess is that this guy is a drug dealer working with the others.

There have been many websites that came into us that need investigation, every communication since I arrived in Spain needs looking into, some sites are, Energy Site, Yes Women, Complete Spain, Bean Freaks, there are many and the date can be taken straight from my computer by the investigators.

Fuengirola

I eventually ended up in Fuengirola, I tried to get my website business going again that i had in the UK, and have just about managed to survive. Jayne and Alex have moved out to be with me, Alex has missed his last year of school because of this. Ever since I have been here I have been followed and had my phones bugged. In Fuengirola someone from the British Drug Mafia has gone round telling everyone not to do business with me because I'm a grass and acted against them and that if they do business with me they will be harmed. But the truth is i was investigating them for MI6 and has a legal right to do it, i was allowed to investigate my case and find out who the drug traffickers were.



Faisal

British Drug Mafia member Faisal runs a cover business, a bar called The Old London Pub (now closed). It was a front for an operation, most likely for terrorists in his home country, bringing in Heroin and Pakistan Black Hashish and buying arms back there.

James, the guy with the beard, is a main guy who works for Manchester Morris (AKA Johnny Morrissey) drug gang and member of the British Drug Mafia.

Bobby (robert16sunderland@hotmail.com Mobile 633166678) also a member of the British Drug Mafia and a long term con man on the coast running scams like Toni Muldoon, with a guy called Andrew (Andy) Smith (952922361, 672112398, 633186678) who had a company called Bamboo Media which was another British Drug Mafia front for conning people with scams like PPL just the same as Tony Muldoon. It's clearly organised crime on a huge scale and falls under RICO laws, they are all one firm running different criminal enterprises from the British Drug Mafia funding it.

Faisal holding the trophy he organises the whole trafficking outfit, he goes out once a year to Pakistan and organises the trafficking, and then brings guys from Pakistan to the ta Del Sol to run drugs for him. He's from London.

Nick and his dad Roger runs a porn business as a front in Fuengirola, the front was run from this office by a guy called Sammy (616564846, 952592817).

Chris (GRGPrint.com) and Jamie Gallager are Nicks partners in the business, (they had several print businesses in the UK) they are all a part of the British Drug Mafia. What they do is go out to Ecuador, where Nick has a supposed girlfriend, while they are over there they organise Cocaine runs to Spain for the British Drug Mafia, last time Nick came back from Ecuador he brought me a box of Cocaine leaves to make tea with, it sort of says it all really!





The bar at the bottom of our road was the Old London Pub, it was full of UK villains and traffickers, I got in with them to start, and SOCA agents were turning up to check me out, I pointed them out in the bar openly! They ran a system in this bar where a Romanian Mafia guy called Alex ran the selling of drugs through the bar and Fiasel the owner stayed out of it so if it went wrong they did not lose the bar, but they were in it together and the bar had a crew, it was a British Drug Mafia den.

With the money from this job Jayne and Alex moved out to be with me.

Many years ago I knew the guy before him, John Evens, he worked for the British Drug Mafia running drugs around Spain, they used to pack the drugs into the legs of the pool tables and move it that way, same old game now.

I found out one day what he was, from a bar owner and confronted him about it, he asked me to meet him in a bar/cafe in the square at Fuengirola. He was sat at a specific table pre arranged. Nick was in the shop opposite round the back of the street, they were trying to scare me off, so they had a guy come to us pretending to have a broken arm, pretending there was a weapon in there, it's an old trick. I don't scare at all, so I got up to knock him out, but the bar tender who was watching the incident stepped in. So I went round the back of the street having seen Nick through the window, I walked into where he was and he and Jamie Gallagher nearly fell off their seats he thought I was going to attack him, so for me it just confirmed everything I knew already. It is so you instigate the conversation, it's a standard undercover operational procedure to never instigate a conversation with a target, they have to get you to instigate so it's more secure. It is possible that Philip Murphy is British Drug Mafia and not undercover police, but there are other mitigating circumstances that make this unlikely.

One night at Feisal's bar a woman came in who also worked at the same building and office as Philip and Tony, they were Scandinavian Europol and she brought with her a National Crime Agency guy who came straight up to me and leant over to my ear and said, we know all about Richard Thompson and we are going to sort it out. I was not sure who he was, so I left the bar, he followed me, I have had training in counter surveillance so I led him up a street away from my home he was not aware I knew he was tailing me, I circled a block and came up behind him. He was stood at the end of my road having lost me. I don't know who he was but I would recognise him anywhere as he had unusually big eyes, Faisal also knew who he was, he said to Faisal, you keep it shut or you will be shut out, loud, and Faisal normally vocal and strong in character just nodded, so I can only assume that Faisal is under the thumb and an informant for the National Crime Agency.

While I was working on the new website for Philip Murphy at the offices next to the train station a woman suddenly started work with Tony Seville. She was on a laptop literally right next to me on the other side of the wall, I knew she was plugged into my network I could see her, there. So she was trying to see what I was doing and not doing any work. I decided to test her and walked in she slammed her laptop shut; a normal person would not do that. Tony also started to turn up at Feisal's trying to get into me, and was also there the night the Scandinavian woman came in with the NCA agent. I said to him that day are you following me and laughed, I could see by his reaction he thought he was blown and I did not see him again either at the office or Faisal's, when I inquired about him they said he had gone bust, but that was a lie, and I found him a few days later.



It happened when I was approached by Tony Muldoon again, asking me to work for his British Drug Mafia business conning people. I said I could not be around anything illegal (but I needed the money) so I thought I would give it a try as he said he just wanted me to handle commercial website jobs that they were getting. I insisted to be in total control or I would not do it as I needed to know it was straight. He agreed, I started the next day.

When I arrived there (Calle rodrigo de triana, 2 Bajo 1 - 4 planta) I was shown round and introduced to everyone as the new guy in charge, I logged onto my email account in there and the network went down instantly, this is a technique to get access to someone's account, as my screen goes off it does not on theirs as its still logged in, that way they can download my mail history. So I knew from being there 30 mins they were trying to find out what I was doing re the case for someone.

While I was being shown round I saw the National Crime Agency agent sat at one of the desks, I went straight over to him and said what are you doing here I'm the new boss here? Tony Saville said he was renting an office there from Tony Muldoon. I could see he was very agitated and nervous, I later found out why. I only stayed at the office until midday and I made an excuse to



go out. I walk straight down to Muldoon sat on the port who was clearly very worried at my approach to him he thought I was going to hit him. Some heavies appeared from the port and sat at our table. I told Tony that I would not work for him. The following day, Tony Muldoon was arrested and his whole operation was shut down and he went off to the UK on extradition and got 6 years. I was not even contacted! This clearly shows that the National Crime Agency were watching me and Muldoon. As they knew he had stolen my email account that had some important information that could be compromising to certain parties on. I am sure that's why they took him down that day, they clearly knew all about his operation for some time. The take down was a necessity for them not to be compromised as I knew their Agent was in the building.



Phil put another man into me with the ruse that he could help me; he was called David Mackay (davidcm663@aol.com) British Drug Mafia/National Crime Agency? He clearly knew nothing of business he was just trying to find out what we were doing. I blew him out quickly as a time waster. Phil then put another guy into me; this guy I knew was in the British Drug Mafia and would not be a NCA agent Richard Taylor (this is why there is confusion over who Phil is. He appears to be working with the NCA and the British Drug Mafia). While at Phil's office one day he got a call about the purchase of the London Pub and that whole block it was for sale for £5 million pounds, it was from the Irish Mafia, they were asking all about the "bungs to local police and mafias re

running the club". Again this is why there is confusion over Philip, he was either working with the National Crime Agency or they were watching him and had something on him (would not have been hard).

The next guy was Richard Taylor (656468354) from the British Drug Mafia and an enforcer/fixer for the British Drug Mafia, he told me how they had forced some young cocaine traffickers out of Fuengirola for trying to muscle in on their territory. It ended violently with one man nearly dead and another injured plus the young guys were out and left the country. I met the two lads concerned prior to this. It was a turf war over some important bars in Fish Alley home of the British Drug Mafia. His son was Kieran and he is Spain's Ti Chi Champion (699155683) I don't know he was involved in anyway, I mention him solely for the purposes of tracking down the ID of his farther. He was supposed to help me get the new business running.

Another guy Philip put into me was David T Mackey (618132839) davidtmackey@gmail.com hotsales@hotmail.com He was just messing us about and was British Drug Mafia.



I went out with Philip one night and he was entertaining a guy who was supposedly looking into buying a business in Fuengirola. I knew he was a drugs trafficker straight off having spent years investigating them and providing MI6 with the names of the whole drug Mafia at that time this is also in the court papers from the UK and verified by SOCA at the hearing who testified for me not the state.

I got him legless and got him smoking some really strong Marajuana he could not stop talking, he said he had come down from Javia from Kevin Concannon, the leader at the time of the British Drug Mafia. When in England, I spotted Kevin Concannon in Macclesfield, he was in the shop Mail Boxes that Jayne my wife worked. He came back to my house with me, and a QSG (Quality Street Gang) enforcer. I told them what was going on and they swore blind they had been watching but they were not doing it. So you have to ask yourself, would a British Drug Mafia guy expose himself in such a way if he was not involved, why? Concannan hired a private eye in Macclesfield to watch me. I caught them shooting green lasers at the house trying to listen in to what we were doing. I found the detective agencies phone number and I called the number but the last digit I changed to one number higher and came in on a second line. I said its Kevin is he about, they said one

minute and the Private Eye came on the phone, I said who the fuck are you, tell the truth or I will be at your home in 15 min Minutes. He said he was working for Concannon. So it's clear that the British Drug Mafia are involved but to what extent needs to be determined by the court.

At the completion of the new website for ta Property Shop, Philip said he had run out of money, he said that his wife had come over with the kids and he spent all the money wining and dining them £25,000? Not likely!

Philip still owed me £3,800, I gave his name to a Rumanian Mafia guy to collect my money for a fee, to see who he really was, as I knew if he was a cop he would be gone in a flash as he was blown. They went looking for him but he was no longer showing up in the bars that he used to use. I never got paid. He has now re surfaced with a new company. https://twitter.com/philipthespur

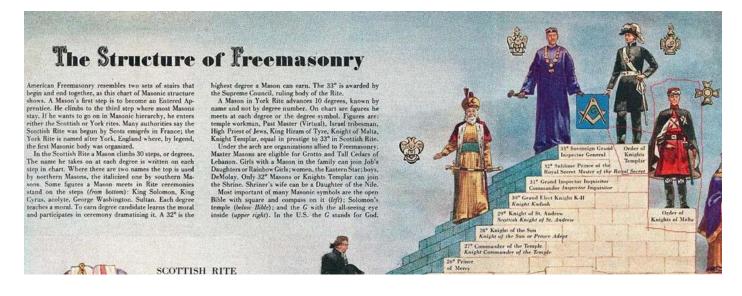

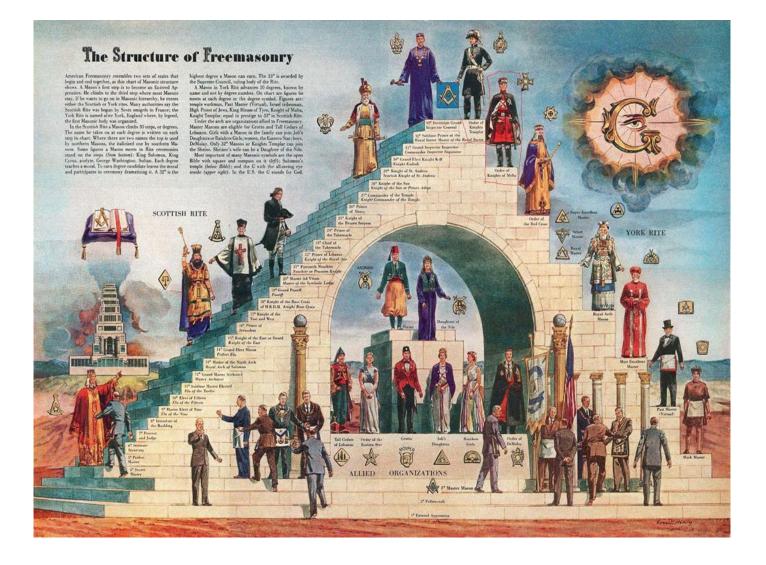
Bruce (Member of Knights of Malta, Mason) at the Toucan's Pub Fuengirola

She had been briefed to come into me by the British Drug Mafia. At the same time as Lesley was trying to come into me, so was a guy called Brian Stevenson and they both knew each other.

Brian and I met when Rodger Griffin from the British Drug Mafia (Nicholas (Nick) Griffins Farther) took me to Dylons Bar in Fish Alley a well known Drug Den. (Brains home, 952199345, 679891495, 603126282, Brian's sales number 08451088668).

Brian pretended to be a sales guy and claimed to be organised enough to run a team, but he was not, he was trying to stop our company from getting work and passing it to the British Drug Mafia businesses like Andy Smith and Tony Muldoon had on the coast.

I have his fingerprints to identify him officially (**Evidence Item 15**); he was best man at the wedding of the Bar Owner who also owns the Britannia Pub (London Mafia Owned) next door. The owner of the Britannia Pub took me to one side and said you do realise that I am London mob don't you? Meaning the London Drug Mafia all part of the same people that know each other down here in Spain part of the British Drug Mafia made up of crews that have been around and know each other for years which is the very definition of a Mafia.

Brian then started to follow me around with others in Fuengirola, they were trying to stop me doing business, the others involved frequent the same bar, they start to use heavy surveillance on me and everywhere I went they arrived.

I am almost certain this is Malcolm Edwards brother as I have visited the QSG furniture business in Gorton Manchester with a QSG member called Danny who worked for Ian Flood, it's clear they were importing drugs in the furniture. Danny was a dealer in Stockport fronting as a shop called Unique that sold unusual furniture. When Bredbury Hall was sold by the QSG (change the name the games the same) all the furniture from there went to Danny's shop, it was all in the foyer of the Hotel, I recognised it as soon as I walked in. There is a whole other story here all revolving around Brian Dignan and the QSG that needs to be investigated. Dave came into me and gave me some website work, once I had completed all the work and it was brilliant, they took it all down, exactly the same thing that has been going on all the time, I do a site and it does not go live.

This is Malcolm Edwards Brother the guy who holds the purse strings for the Quality Street Gang, Stockport Mafia, all through my case they have been involved and before I came to Spain.

When I was first imprisoned I only had one visitor, and it was from a representative of the QSG, they sent me a message personally delivered to me in Malaga prison. They said it was not them that set me up. But if it was a set up, I have doubts of it being QSG, my question would be why would they send someone to the prison exposing themselves to the case? These guys run drug and arms for the IRA, so there is a connection that needs investigating for several reasons.

First was when a girlfriend I had called Wendy Brown asked me to go to boxing at Oldham promoted by Jack Tricket, with Jack Tricket and her (Honey Trap). I was a prolific fighter at an early age in martial arts and sword fencing of all types, they had a boxing club called Stockport Lads club. I joined and fought the biggest guy there first and floored him. They threw me out of the club. Jack heard about my skill and wanted to get me to train as a boxer, my farther fought in the golden gloves and taught me to box from birth. I had heard of Jack Tricket from my farther he called him Tricky Tricket, so I refused to go. They asked me over and over they were trying to get into me as at that time I was famous and they wanted me to go to their Bredbury Hall night club run by Dougie Flood QSG. They also wanted me to go to Acton Court Hotel QSG Hotel Night club/pub. I always refused to go. Apparently Jack Tricket was very angry about this. He was used to getting his way in the town and had corrupted the whole place with the Mafia stink.

Years later when I was in Puerto Banus living on a 90 foot yacht in the harbour, I used to go out every night to the clubs, it was all mafia run then and clearly now. I used to drink every night in a bar called Jukes a famous place back then. One night Duke a great character from the London Mafia came out of the back stopped all proceedings in the bar and said I have an announcement, I have just sold the bar for £500,000 pounds to Jack Tricket, everyone cheered for him as he was liked and as I turned round Jack Tricket was stood there and he said to me, I knew we would meet one day, I said nothing to him and walked out and never went there again.

I was told by my Auntie Florence that Dougie flood jumped over her wall and stabbed her dog to death over Brian Dignan another QSG figure, Brian was engaged to my mother and after my Farther got leave from guarding Rudolf Hess at the Nuremberg Trials he went to my mother and told her Brian said it was OK to take her out. They had a life long feud on and off about it. Sometimes friend and sometimes enemies.

When I was living in the UK I was attacked in my own home by a man called Joseph Zammit who was recruited to the QSG by Carl Jones both from Bramhall, Stockport. He was drunk and shouting he was from the QSG and that he wanted a cheque writing out for thousands of pounds. He cut my throat and I was bleeding, so I called the police, it went all the way to court and he was convicted and sentenced.

After he did that, I was caught off guard at the time as I was knocked up out of bed and overpowered. So I went to the QSG pub the Jolly Sailor where he drank and went in and stood next to him, he was physically shaking and everyone in the pub stopped talking as they had heard I was well know in the town as a musician. He did nothing. Then we stayed there looking at him all night until he left. Some told us they heard him calling someone to try and get us attacked as he could do nothing as he was on bail.

We went to the QSG nightclub in Stockport to show I was not afraid of them. When we came out, 4 guys attacked us from the QSG, they fought with everyone except me, I just stood there, they had been told not to touch me.

When I was in Fuengirola I asked a member of the Rumanian Mafia to see what he could find out through back channels about my situation, he came back to me with someone who he thought could help.

It was the main guy from the QSGs (part of the British Drug Mafia) called James. He works with the Manchester Morris Crew (Johnny Morrissey). He said that he could get it sorted out regarding money i was owed. So I shot one across his bough that I knew they could sort out quick. Some Stockport lawyers I had were lent on by the QSG to stop trading with me or they would pull their business from them.

The guy who did this was Paul Gorton QSG. At the time I had won an industrial tribunal and was awarded £80,000 back salary in compensation and given leave by the court to sue for £1 million pounds, it was impossible to lose. The lawyers just stopped calling me and said they could not help, I never even got the £80,000, so I said to James get me the £80,000 first, he said "we can do that and go on to get the rest".

I waited a couple of days for him to make phone calls, then Alex the Rumanian Mafia guy set up another meet. I met with James and asked has he managed to sort anything he said he had and it was in the pipeline, I asked him "so the lawyers agree then" he said they would pay it out of indemnity policies they had to cover things like this. I knew he was Lying as I had asked them the same day. So I told him he was lying and left the bar and have not seen him since, but the Gang Stalking got much worse, taking on a whole new dimension covered later.

When I was living in Poynton just before I was extradited, there were workers at my house and one of them had a quite word with me and said you should speak to Ian Flood he's not as bad as his farther. Ian Flood, the New QSG main guy sold his father's places and bought a £5m farm where I lived in Potts Shrigley.

When the worker told me to contact Ian Flood, 30 seconds later there was a knock at the garage door where I was working at home, it was a police officer undercover, and all he said was I OK, I said yes, it was so strange as I never opened the garage door, and then he left. There was also a guy who ran the builders called Johnny and he had had run ins with my family over building work, so it's clear that the QSG had a grievance against our family.

While I was in Stockport after I came back from Spain, an investor came to the company that I had and offered to put up £50,000 this was Paul Gorton QSG. I asked him how he got the money to invest as any Director would under Due Diligence, he said you don't want to know, his partner called Jayne was a mobster's wife and married to a top guy in the QSG and while at her house in Oldham she told us that the money came from drugs.

I left the company the next day, I said I had other business to do which was true, I then tried to set up a company with a guy called Francis (Fran) Donahue who was from Wilmslow. He was threatened by the QSG not to work with me, he told me this himself, he said they played him tape recordings of our calls to show they were listening and if he tried again he would be in trouble, he left Manchester and went to Puerto Banus!

Paul Gorton also tried the same thing with me he called me up and asked to meet, I went with my wife Jayne, he was with a huge guy he said was his brother, he played me tapes of my calls to Donahue. I just said so what, he said, I had made to much money out of the deal, but I did the deal through my lawyer and it was all correct. That's why he went and threatened the Law firm and they dropped my work, I had paid them over £70,000 in legal fees, but the QSG carried a lot more weight than me, so I got dropped in it. Paul Gorton also went to my accountants and threatened them too, they told me that they could not go against them in the town and I got dropped from them too, leaving me exposed and helpless which was the intention. I have been Gang stalked ever since.

It's not yet clear what involvement they had in later business issues or that they are the Gang Stalkers. The reason for this is that there is another two candidates.

However, I started a web design company in Stockport called IT Panache, I was going round looking for work, and a man on Underbank in Stockport who sold DVDs said he would have a site. Once I started the site he came to me and said would I be interested in investment, I said sure I would listen and I had a business plan to roll out.

I was taken to an Italian restaurant where I met with a man called Malcolm Edwards, he is the banker for the QSG, and they use Laidlaw bank, at the time I did not know him. He offered to put up \pounds 100,000 and I would get \pounds 600 a week to cover my expenses. I agreed and started and he spent about \pounds 80,000 and we came in under budget, we started recruiting sellers and it was going perfect, please see exhibit UK1 for an outline of the company. (Evidence Item 16 Technology Partner - BUSINESS PLAN)

The business was flying, I took £14,000 in the first week of trading with very little outgoings, we were making money from day one.

One day out of the blue, Malcolm decided to show me who he really was, I said where are we off, he said to look at a business I want to invest in, he wanted my view on it. We went to a Gym in Stockport under the train arches. The guy who owned it was called Pat he had run out of money about half way through the project. The work they had done looked good, and the venture looked good, until! After we finished the money discussion on the investment out of nowhere, Pat said to Malcolm, I have to apologise about the Irish situation, guys were waiting outside for us with

machetes from the IRA, and I knew I could not take them on that's why I called you. Malcolm said no need to thank us (meaning the QSG that provide explosives, arms and drugs to the IRA).

The QSG worked with the IRA then, so he called Malcolm into stop the situation. In my view it was the QSG that put the lean on the Gym using the IRA as they owned a piece of everything in Stockport but I don't know that for sure. Thin Lizzy did a song about the QSG called the boys are back in town, this was from Doblin in Ireland where they were seen as helping Ireland get independence from the UK, i have had this confirmed from Phil Lynot, singer in the band.

Pat went straight into another conversation about the killing of the guy in the boot of the car in Stockport found in Buxton by another QSG guy who was the brother of my song writing partner Alan Blood. He said, they put a hit on us for £17,000, as we were encroaching on their territory which was Heaton Norris, Stockport. I knew all about the case they were openly talking about, two guys were kidnapped in the boot of a car and one made a call to the police on his way to his death. They beat him to death and set him on fire in the boot of the car, it was a famous case back then.

When we came out of the Gym Malcolm said he's got a big mouth that Pat, and said nothing about the fact that he was laundering drug money through my company, all very odd, and I did not believe it at first, so after Malcolm Edwards suddenly disappeared with my £20,000 and stopped the money. I discretely phoned Stockport police away from my house they came to Birchencliffe Farm where I was living and confirmed I was right but could not act and they could not find Malcolm Edwards to question him.

My sisters brother told me that he had met Malcolm Edwards at the Gym on a trip out here to Spain so someone is lying as he was right there! Maybe it was fake cops or they were paid by QSG.

After hearing the conversation I was already trying to pull out of the deal, I stopped going to work, made excuses I wanted more money, then the communications stopped with Malcolm.

At this point there was a strange occurrence, Malcolm and his partner Adrian Roscow came to see me. Malcolm said had I burnt a car from his garage? I did not even know he had a garage. He also asked if I had busted his windows and set off his alarms, I said no why ask me? He never asked again but the next day he picked me up to go round with him for a day. He asked me about what happened in Spain so I told him what I knew, he said that he had spoken to everyone I knew, I said as if, he said name one, I said Paul Young from Sad Cafe, he got out his phone and called him and he had.

He told me that he knew Rory McCarthy and was a long time personal friend of his, he said years ago they used to fly cargo planes from Spain to the UK inferring that they were moving drugs. This brings into play a different scenario, McCarthy are the company that owns one third of Virgin, they are a public listed company out of the Canadian stock exchange. They could also be responsible for the theft of my company and IPR and could of hired QSG through his contact with Malcolm, assuming it was true Malcolm Knew him.

He told me that he had spoken to Mark Dennis my business partner from DAPPA a web publishing company and that Mark sent his regards and told Malcolm that I was a business genius.

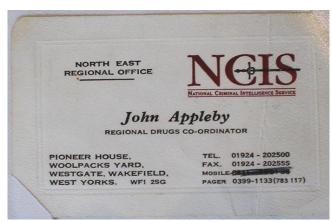
Then after we spoke he said that he had been called into his Masons Lodge over me, and that I was not to repeat it as he would be in trouble, he asked if I knew what it was about? I only knew one set of Masons Anthony Keaton from MI6, Brother Ralph Keaton and Martin Burr all from the same Masons lodge, I knew masons from London also and they were linked to the others in that

they came to our Scunthorpe offices and these were the people that stole my business and IPR that started this whole charade of the false case in Spain. I never saw Malcolm again. I did report him to the Stockport Murder squad and had meetings with the murder squad over the Pat incident. Stockport police said they knew I was telling the truth but they had no evidence.

Calling In The National Criminal Intelligence Service Armed Response Unit:

I had figured out what was going on by this time and was trying to get help from the Police that were mostly Masons, so no help there. I called the number I had for NCIS (National Criminal Intelligence Service) that I had been given if I had any trouble. I got a call back from an agent saying that we were to meet at the Valley Lodge Hotel in Style Wilmslow, when I got there I was met by a guy called Dave Whiting who said he was with NCIS, I had seen this guy years earlier and he was a Wilmslow CID guy, I was dubious about him. There were several other officers all with bulletproof vests on, watching the car park outside.

This is the phone number 013991133 and gave my code to call an Emergency armed response team my clearance Agent code was 783057, my NCIS Contact was Chief Keith Crawly who I was introduced to by John Appleby NCIS. This has already been confirm in the Royal Courts of Justice UK High Court in London under National Security protocol CAMARA case number CO/5173/2009 held in CAMARA (I have all the document should the court wish to read them, as you would not qualify for security clearance through normal channels). I was briefed on how to do this on my return to the UK by two NCIS agents it would call an armed team to my location. They said go to the Valley lodge Hotel in Handforth.



I was met by a guy I knew from Wilmslow David Whiting, the friendly face, they were all in bullet proof underclothes with big jumpers over them to cover who they were, as I entered the car park I could see they had the place locked down outside.

Dave took me inside and we sat having a drink he was with a Liverpool guy who he said was also NCIS, I started explaining about what was going on, starting with Malcolm Edwards putting up $\pounds 100,000$ for a business and then he just walked

away after, someone burnt some cars on his car lot and broke into his house. At this point Dave jumped in and said there was only one car burnt, I agreed, but wondered how he could know that! I am not convinced that Dave Whiting was with NCIS, he could have been local police Masons, who were involved in the harassment.

Valley Lodge NCIS Meeting Same place now I asked NCIS to get me a change of ID so we could move and carry on our business as we could not make any money with all the Ring-fencing and Gang stalking going on. They said they would look into it, I heard nothing from them.

I was taken inside and met what initially appeared to be two NCIS officers. They said what's the issue, I said we have been getting followed everywhere and threatened even on the farm where I lived that was stopped by locals. It was no longer safe there. I explained what had happened with Malcolm Edwards, and I said to them that they drove cars off his garage forecourt and burned them, the NCIS guys corrected me straight away and said it was one car. They knew all about it, I am sure these guys were not NCIS and I wish to get this confirmed in the UK part of the court case coming up on Gang Stalking to be filed in 2018.

I want an investigation into did David Whiting and Wilmslow police. Did they intercept the call to NCIS (either as paid cops by the QSG, or as Masons), as they were involved in the Ring Fencing

by the Masons, Is David Whiting a Mason? Did he try and stop the truth getting out and perverted the course of justice? If so he did it with the Masons as the police had no authority to act. If this is true it is conspiracy to pervert the course of justice and reckless endangerment to life, I demand this is investigated and charges brought plus a civil lawsuit.

There was a third man sat away from us, and I have unusual good peripheral vision I was watching him listening to our National Security chat, and I pointed out that this man was looking, in fact I stared right at him for the first time and pointed him out he nearly fell of his chair. David Whiting said don't worry about him he's with us. I recognise this man as being involved in the stalking that has gone on in Spain, he contacted Philip Murphy and I saw him have a meeting with him about me at the end after they had paid me around £27,000 pounds for work that was never live on the internet.

Philip Murphy needs to be brought before a Spanish court and questioned about it as does David Whiting in the UK. We already have a strong case of Perjury and perverting the course of justice about to be filed in the UK against the same agency now called NCA National Crime Agency (previously Regional Crime Squads formed up to due to the fact it was so corrupt it could no longer operate and was facing huge lawsuits. NCIS started and the same happened again and then SOCA Serious Organised Crime Agency and the same happened again, now we are filing a £4 billion pound lawsuit against them along with others that will again end them. Ever wondered why they keep changing the name?

Knowing what I know about Malcolm it's hard to believe that someone could lean on him, other than the Masons, that is the only place he would not have the say.

So as you can see overall when you read carefully between the lines there is a clear case that its the Stockport QSG, however, there are things that don't add up.

In the murder case that I was arrested for but never charged, one of the British Drug Mafia members called Barry Unwin took me out from Calahonda to Fuengirola one day. We went to see Manchester Morris at the Old Vic pub where he played high stakes poker with Jonny Stokes (London Mafia) and other well know British Drug Mafia guys. I was not aware of any of this at the time but I was a keen poker player and so spoke to all there and asked about the game etc. Jonny Stokes was not there, Barry was looking for him, so we went to the snooker centre where they had their own place roped off, I was not allowed to go in beyond the ropes so I have no idea what was said, all I know is that a few days later Tor was dead and everyone had disappeared, me included, all spoken about in the case files. I can't say Manchester Morris is involved, but here are some facts:

Here is what Jonnies grandson says he knows:

"My grandfather then joined the British Intelligence service and got his son into it my father Johnny Morrissey. He got trained in the TA British territorial army he then was placed to infiltrate organised crime and I,R,A movements. He got a job on the doors of nightclubs as a bouncer. Then the intelligence service arranged for him to go to prison by pretending to beat up off duty policemen, all a front orchestrated to give him a background for prison.

In prison he met members of the Quality Street Gang an IRA Fundraiser. He befriended them and caught there eye as being very violent and very capable. All the time he was leaking intelligence to the government. Once out of prison he joined the Quality Street Gang and moved to Rochdale (Paul Gorton lives in Rochdale who infiltrated me and is a member of the QSG). He worked with IRA members including Eddy Hegerty and Jimmy Swords (AKA Jimmy Monaghan) and Jimmy (the weed) Donnelly. My father was the guy who the British Intelligence called on to kill the IRA members, they could not be seen being apart off, and rise up through the ranks of the quality

street gang the main Fundraiser for the IRA, with British government sanctioning his criminal enterprises including drugs, extortion and murder. In exchange for intelligence on the IRA and Quality Street Gang."

Members of the gang involved in Tors subsequent murder:

Barry Unwin, Strong Arm, DOB: 28/11/1937 From Wandsworth

Served 9 years out of 15 for providing explosives to the IRA, in Dartmoor prison. At the time of Tors death he was just out of prison in Spain for running a guy over because of a drugs deal gone wrong, it was attempted murder. I went into Fuengirola with Barry one day only to pick up some English food, on that trip Barry Unwin was a friend of and introduced me to a guy called Johnny Morrissey QSG member, and Johnny Stoke London Mob Drug runner all British Drug Mafia.

Alan Wilcox the Ring Leader, DOB: 31/10/1934:

Responsible for a series of famous armed robberies all over the UK, he was the regional branch manager of Barclays bank and with figures from the underworld planned and executed the robberies. Along with many crimes in Spain and other countries, he was the ring leader and got caught bringing in £500,000 in to Spain from the IRA, from southern Ireland to Spain through Gibraltar by a judge investigating him (the same judge in my case, the judge told me this herself), he had been arrested with eight different identities in Spain alone. Alan Digo, William Day, George Garforth were three of the names the judge told me. Wife Jan son Alan Peter Wilcox, A UK address i was given by the court was 16b Derwent Court, Childall, Liverpool.

Colin Bracket, Wilcoxs Partner From Brighton

Cocaine deal fixer posing as a band manager, it was well known on the coast that Mel Williams was selling kilos of Cocaine that's the guy who i was playing with at Banana beach and the London Underground nightclub all set up by Colin Bracket.

Bod Bracket (Colins Son) From Brighton Was selling drugs when i met him only saw him with Marijuana.

Roy Rochelle (Name on passport when arrested) DOB: 23/06/1943, Strong Arm. Roy born originally in Birmingham, was a side kick to Barry Unwin, Roy openly spoke and confessed to the murder of a guy in a wine bar in the UK in Halifax, he had many names, his real name was Roy Edwin Letts. Roy Rochelle introduced me to Barry Unwin at the Port Hole bar the night of an issue with another drugs gang. Dads name Eduardo, mums name Emily. Wife was called Val. Got an address from the judge as 58 Arden Road, Smethwick, Worley, west Midlands. There was a person named Michael C Rixon from Halifax re the case where Rochelle murdered a guy in Halifax. This needs investigating.

So you tell me? If this is a coincidence, the person that started the Gang Stalking order on me was Ralph Keaton Scunthorpe Mason, his brother Anthony Keaton who I have met is an MI6 Agent working undercover in the IRA. Barry Unwin served time for providing explosives to the IRA, Barry Unwin was a good friend of Jonney Morrisey member of the QSG who provide explosives and arms and drugs to the IRA. Alan Wilcox, caught with £500,000 pounds of IRA money to launder on the ta Del Sol? Can that all be a coincidence? Add to that the QSG held and robbed me at knife point and the QSG Jack Tricket continually trying to get into me? The only people ever to deny they were involved in the murder set up were the QSG. Those coincidences are now beyond all reason and there is a lot more to come in the case.

One thing I do know is that all the time I have been writing about the QSG I have been attacked with Direct Energy Weapons, another indicator? Or is it someone trying to influence the outcome?

This is the whole reason it has to be investigated at a National and International level using police that are outside normal police channels like Judicial Police that are used to investigating Organised Crime which this case is. Masons? British Drug Mafia? QSG? All of them via McCarthy or Thompson or most likely in my opinion who started it was Wayne Lochnor, Terry Plumber and Chris Britton all Masons, all MI5 & MI6. I have a tape recording of Wayne Lochnor MI6 former Honk Kong Chief of operations, on the tape (**Evidence Item 2**) the Managing Director of my company and my lawyer were sent to meet with Lochnor. He did not know who they were, and proceeded to sell my IPR to them which MI6 and MI5 stole from me as agents from MI5 and MI6 will confirm in the trial. On the tape at the end after he had finished and we had the evidence to convict them, my lawyer informed him that they represented Gary Owens and you have no legal right to sell this information. He audibly snapped his pen on the table in shock, he tried to do a deal with them and says on the tape that if they help Ring Fence me he will do a deal with them. It's a straight imprison-able offence and we are filling this case in the UK on my return. It's also irrefutable evidence taken by a ward of the court.

The point here is that Lochnor is a Masons and before Gang Stalking the masons would Ring Fence people surrounding them and ruining their lives so the Masons could steal their businesses. This has been going on for decades, and we are filing a £4 Billion pound lawsuit against MI5, MI6, NCA, and all individuals involved jointly and individually liable, and we are attaching a proceeds of crime order on the Masons for the full £4 Billion pounds to be charged as a lien against all properties, bank accounts and investments.

This is what the extradition case was all about, stopping the lawsuit that will end the Masons and MI5 and MI6 as they could not financially survive the case. Add to that the fact that the House of Lords refused to hear my case because I was a accusing the Masons, even though they were ordered to by the highest court in the land they refused and set up a new court that would not be public, now called the Supreme Court. My case was the first case ever filed at the Supreme Court, corruption does not describe this set of event. I personally will not be satisfied until the House of Lords is disbanded and the Masons are outlawed as an organised crime fraternity which is clearly true. The same applies to the Spanish justice system its endemic with corruption and not fit for purpose.

The only stone in the claw there is that the stalking was going on before Lochnor in a way, with Joey Zammit and in Spain with Jack Tricket. So I really don't know, but the answer is for sure in the investigation and linking the people together via investigation. Another outsider that's raised its head recently is the Norwegian Mafia as Tor was a drugs trafficker. So he would have been with others and had a crew, so this also needs investigation as I was given this information by a Norwegian Intelligence officer with an MI6 officer present. When I was living in London working as CEO and President of a 24 million pound funded company I was infiltrated by a Norwegian agent who Terry Plumber spoke to. This also needs looking at in the UK trial on Gang Stalking.

I have a lot more information that needs to be collated and time lined for an investigation to bring out the truth and narrow the field of who it is doing the Gang Stalking.

The link is clear between Locnor, Plumber and Britton via McCarthy to Malcolm Edwards and there links to the gang that killed Tor are clear with the IRA, QSG are linked with the IRA and QSG knew the gang that killed him, it's not possible that this is a coincidence. A good investigation and timeline will narrow it further along with talking with all the witnesses. , Plumber and Britton via McCarthy knew Anthony Keaton from MI6 through Ralph Keaton and they are ALL Masons!

The person who showed me how to use the IPTV was from Wilmslow in Cheshire.

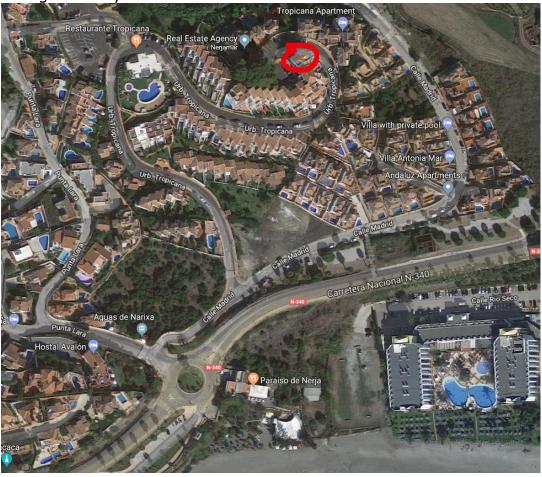

He is most likely a Mason or ex services person as many of the people who he has got involved round here are ex service and Mason guys, the process is always the same they talk to people and lie to them to discredit you so they can ring fence you.

He needs arresting and his assets seizing for Gang Stalking, he is an organiser and as such would face a harsher penalty than the regular gang stalkers. I would ask for 25 years in prison for this guy.

Local Police Corrupt Officer

The next person is Local Police Corrupt Officer? This is his Private car that he used to stalk me in, i found where he lives and since he has disappeared, i did intend to report this to the Local Police Chief but unfortunately he is on the run for theft of arms from the police barracks and other charges So as it's not possible to trust anyone in Andalucía as they are all in the judicial mafia i would like the Audencia National anti corruption and organised crime investigators to do it.

I have seen him use this car on many occasions Registration 2698 DPP and he also used another vehicle but only near my home, this Registration was 2932 DLZ a white Land rover that could belong to the police.

I want to know who instructed him to follow me and intimidate me, and i want him charged with Gang Stalking, i wish to sue him for all his assets.

I went to his home and revved my engine outside his house to bring him out to confront him. Instead the coward hid and called for backup. Two police people arrived and went into his house they were in plain clothes. They never confronted me! What sort of police officer hides and wont confront someone attacking his home, only a corrupt coward does this. At the same time as the police arrives another car came past with a member of the QSG, i recognised him instantly. Just what is going on here, because it looks like corrupt paid by the QSG cops and targeting me on the say so of an organisation that provides guns and explosives to the IRA, some country this Spain is!





Carly Cole

Carly was the first person we got to know in Torrox, it happened when i found 4 dogs thrown away in a bin, i took them down to the animal shelter, Carly was the Manager there. Carly is not mixed up in any of this; she is in fact a victim of it.

I told Carly i played in a band and she said she knew someone, it turned out to be Tracy Lamb (below) who i had known and snubbed in the UK as a poor musician, i recommended that she be removed from the band she was in when asked by the band leader Jody. Seems she held a grudge and went along with whoever is behind this. Tracy said there was a rock concert in Herradura and i said i would go down and play.

Carly is a really great girl and she refused to go to the concert as she knew what was going on, she said to me when I approached her after the gig, I said why did you not come to the gig. She said I don't like it when a group gangs up on an individual. She was sacked from her job for no reason as were the their staff including my son, the woman that runs the dog home is a Gang Stalker called Sue Whewell from Tails Torrox <u>https://tailtorrox.es/</u> a dog charity in Torrox ta (and is a personal friend of Chris Barrett in the charges section above) they are all involved in Gang Stalking, Carly told me she had been stalked by her and her friends. carlycole31@yahoo.es

Also working there was a guy called Jacko (685400695), he was also a friend of Tracy Lamb a Gang Stalker and instigator of the stalking around Torrox or at least in the middle of it. The phone numbers that Simon had at the time was 6455255782 and the phone number for Tracy was 663624194. Straight after this conversation in fact the next day, Simon changed his phone from an analogue phone to a smart phone but kept the same number.

I believe the drug dealer was Kevin Concannon a member of the British Drug Mafia or one of his representatives, the same as happened in Fuengirola with Philip Murphy and in the UK. He should be arrested and held on accumulation of evidence until its sorted out so he can't run.

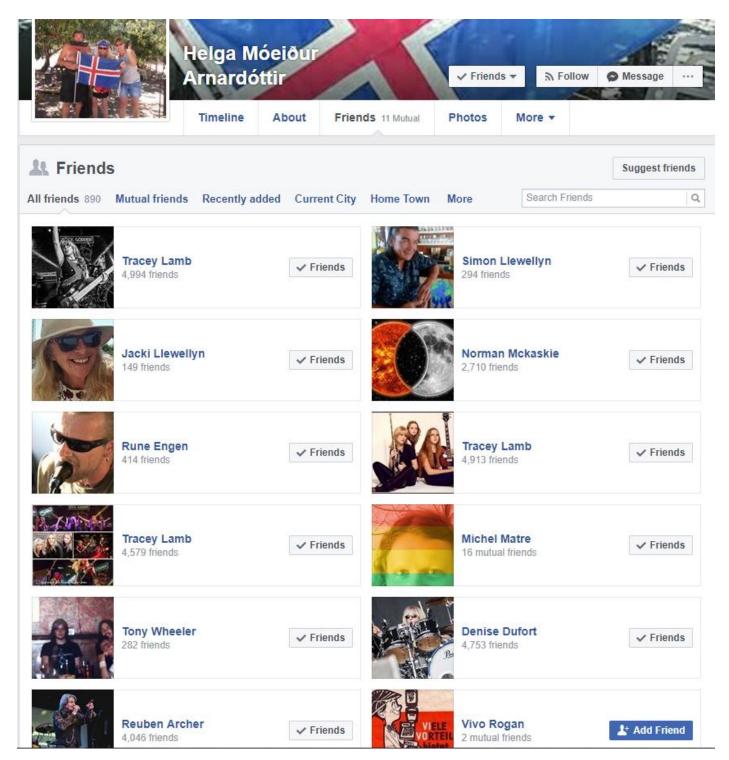

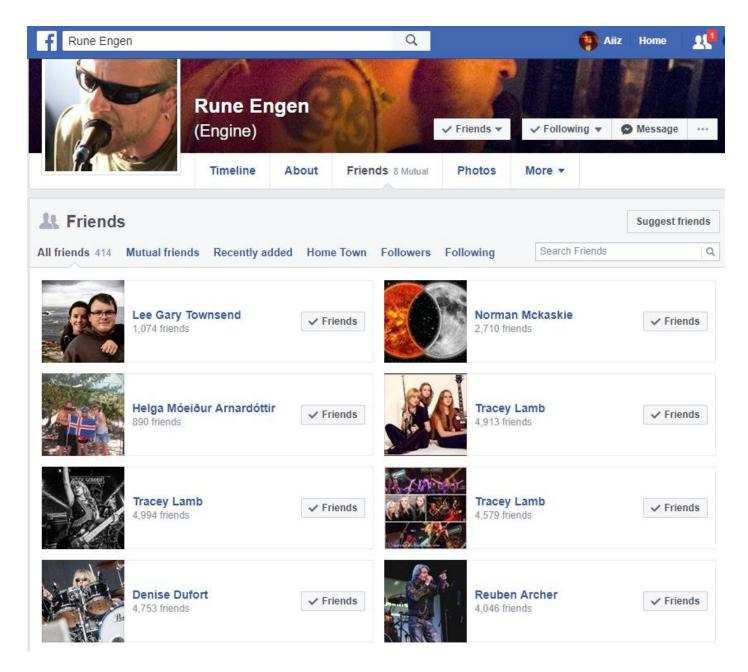

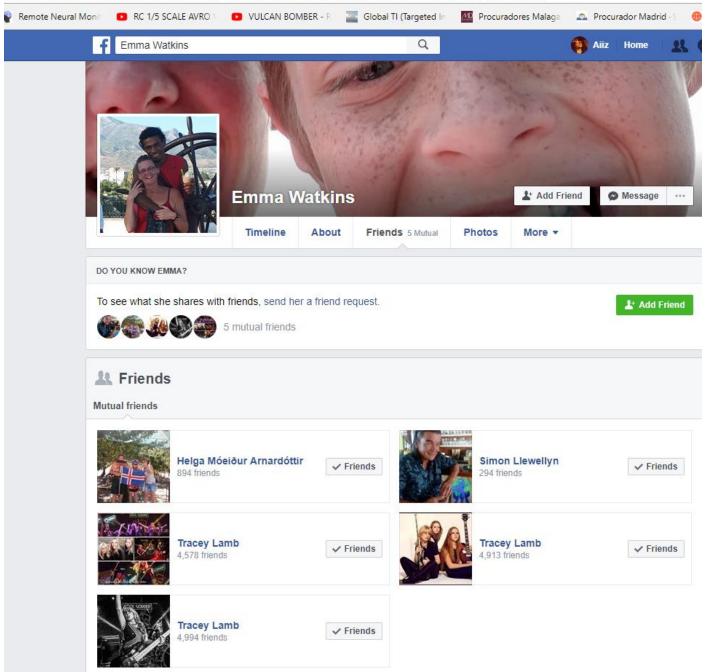
