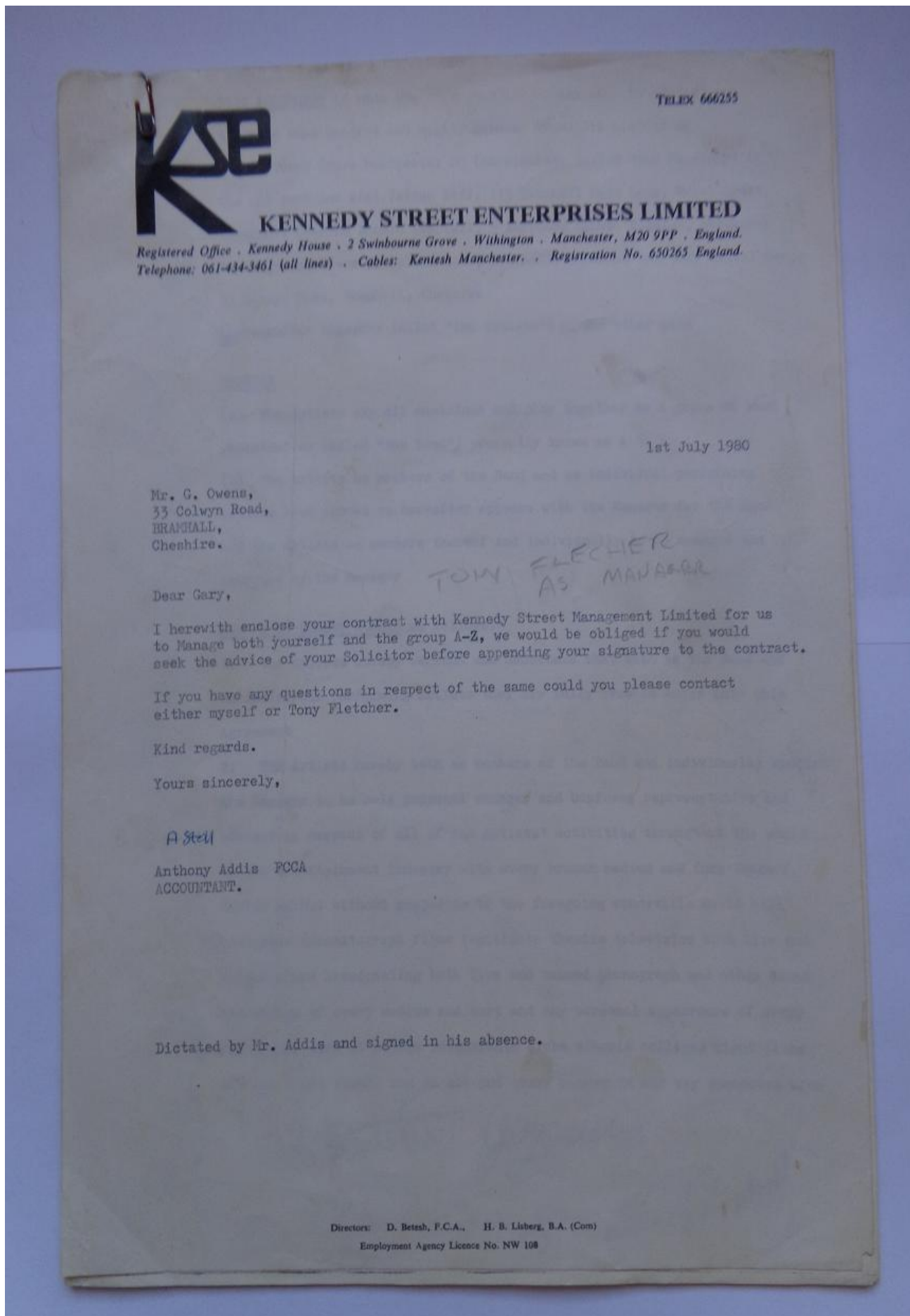


Exhibición 23 - Major Management Contrato con Kennady Street



THIS AGREEMENT is made the SIXTH day of AUGUST one thousand nine hundred and eighty between Armadillo Limited of 2 Swinbourne Grove Manchester 20 (hereinafter called "the Manager") of the one part and Karl Istvan Reti, 115 Bramhall Moor Lane, Hazel Grove, Stockport Cameron Donald Campbell, 9 Harewood Grove, Reddish, Stockport David Joseph Owens 33 Colwyn Road, Bramhall, Cheshire and Gary Samuel Owens 33 Colwyn Road, Bramhall, Cheshire (hereinafter together called "the Artists") of the other part

WHEREAS

- (a) The Artists are all musicians and play together as a group or band (hereinafter called "the Band") presently known as A to Z
- (b) The Artists as members of the Band and as individual performing artists have agreed as hereafter appears with the Manager for the Band and the Artists as members thereof and individually to be managed and promoted by the Manager

NOW IT IS HEREBY AGREED as follows:-

1. The Artists hereby warrant and undertake that both as the Band and as individual performing artists they are fully free to enter into this Agreement
2. THE Artists hereby both as members of the Band and individually appoint the Manager to be sole personal manager and business representative and advisor in respect of all of the Artists' activities throughout the world in the entertainment industry with every branch medium and form thereof including but without prejudice to the foregoing vaudeville music hall burlesque cinematograph films legitimate theatre television both live and canned sound broadcasting both live and canned phonograph and other sound recordings of every medium and sort and any personal appearance of every medium and sort at hotels restaurants clubs schools colleges night clubs and one night stands and in all and every manner in any way connected with

I am writing regarding the group A II Z. I am in the process of getting A II Z's records re released to coincide with a video of the group and a new album and possibly tour support.

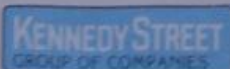

Dear Gary

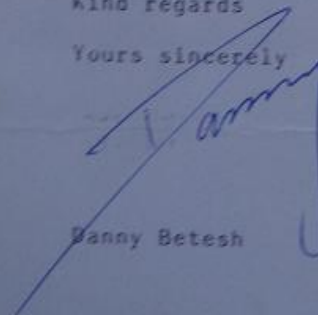
