How can this be? I have been falsely extradited and imprisoned to Spain, then released and held here for nine years without charge, on NCA perjured testimony, all Mason related.

Thanks for your call and help, i know i can push a lot of information at you at once so in the essence of clarity i have gone over the points where we thought you could help.

A/ Jeremy Corbyn's stolen recorded delivery sign for letter and other stolen letters:

I chose to send the letter to Jeremy because of his views on the security services, i firmly believe that MI5 or NCA stole the letters from the secure hanger at Heathrow. The CEO of Royal Mail says it is imposible, but it happened, and he can't say more outside of court. One of the issues we have had is people keep changing at the FCO. As a party you should have a long look at the FCO and its function, it's a disgrace how they treat their own citizens, as far as i can see they are just a front for undercover work.

Suggested things to do:

Contact Jeremy and let him know that the security services have allegedly stolen his mail, let him have the letter and support documents.

We were told that the letter to Phillip Hammond was delivered that also means that the letters to the other five FCO heads below must have the letter also, could we ask them all to find out whose lying? We don't believe it, as we never got a reply from the FCO and none from the Prime minister either, which is not normal.

B/ Get the FCO to answer the questions that can clear up if the SOCA now NCA committed perjury.

This document has the questions i want answered by the FCO, they lied about this letter to Nick Cole from the daily mirror group.

1 - Letter to the FCO and British Embassy 5th November 2015.pdf

In my extradition SOCA stated that they spoke to Toby Childs and Paul Studley Senior Liaison Officer at the Embassy, and that those officers could not recall that they told me to go home in a threat to life situation.

I know for sure they would remember it and i also know for sure they have a recording of the phone call where they told me to go back to the UK immediately. This was pivotal in the extradition and we believe they lied. This would leave them open to charges of perjury, conspiracy to pervert the course of justice and also compensation for me because of false extradition signed by Terrisa May, false imprisonment, and loss of earning from all the companies i lost and earnings and damages to my name and family. I want Childs and Studley brought before a judge in the UK.

C/ GCHQ, MI5, MI6, NCA, Cheshire Police, Lincolnshire Police, City of London police, Scotland Yard.

I have been placed under surveillance that involves electronic surveillance done by GCHQ and explained in part by the Guardian newspaper recently. I have been tortured using this and had my life threatened and have reported this to the FCO and they sent a woman called Anna Timis to see me, the NCA or whoever it was had an RFID Implant put in me at the dentists, i am filing this case as a crime in Spain with my lawyer.

I am bringing attempted murder and torture charges in Spain in the next few week, i want to know who in the UK security services has been keeping tags on me and brought this about, someone has been lied to, to get the surveillance organised i want that persons hide and house.

I can let you have the documents in English that outline what has been going on, it's shocking and something you should be aware of. Especially re the surveillance you will not believe what i tell you, but i have the proof and can now demonstrate what they do, due to the help of several whistle blowers from MI6 Dr Barrie Trower and Dr Robert Duncan CIA, Karren Melton Stewart NSA, these people are in my association, details are in the court documents if you need them.

I will be filing the same cases in the UK upon my return along with many lawsuits and charges including a 4 billion joint lawsuit against the Masons, MI5, MI6, NCA and others who apparently can use the security services as a private army for the Mason. I want to take this all the way and have the Masons barred from any public office.

The surveillance is being used to stop me getting a UK lawyer, this is a Human rights breach, they are doing it so they don't have to face trial. Who is behind it!?

Why is this important? I can't sue them until i get a lawyer so they are interfering with every aspect of it and have done the same in Spain. This is a clear conspiracy to pervert the course of justice and it will go all the way to the EU Human rights courts, charges are being filed here on the 15th of February. I want the people involved in this in the UK courts and i want the system changed that allows these people to operate our public service as their own army. Corbyn is right the security services are out of control organised crime, it's a disgrace.

Nick Cole was onto this whole thing and was planning for it to go to the Daily Mirror, all the people involved in the letter to the FCO that i want answers from are all your current enemies! Terrisa may signed my extradition, i would like to know if i can sue her for criminal negligence. Phillip Hammond, never replied to corruption allegations, surly this is criminal negligence? They stole the opposition leaders letter and prime ministers we believe to cover up their corruption.

Surely there is a big story here for the Mirror? Plus the £5 Million pound compensation I'm waiting for, which Nick was going to run in the mirror and ITV and many others are interested. This is all being stopped by the security services to cover up what they have done. I want them investigated and dismissed and you have to ask if the whole security services does not need a top to bottom re think, maybe this could be taken further with Jeremy.

Point One: Paul Studley and Toby Child from MI6

We would like copies of the Madrid Embassy phone calls made by me to Paul Studley and Toby Child from MI6 from Javea in October 1995. We know they exist, as i was told by both Paul Studley and Charles F Formby Seville liaison officer for MI6, that the calls to the Embassy were recorded and i should be careful what i said when calling the MI6 guys at the Embassy, i was told to call them Liaison officers. The point is recorded conversations are never thrown away and we know you have them, which means you could have stopped the extradition anytime. If someone had spoken to Paul Studley and Toby Child. SOCA said they had spoken to them in the extradition hearings:

The phone calls we are talking about were between Gary Owens and Paul Studley and Toby Childs who we knew as MI6 Agents from the Madrid Embassy. The calls were made from Javea in October 1995 to the Embassy.

We wish to know the current whereabouts of Paul Studley, Toby Child and Charles Formby so we can get affidavits/court appearances from them. They will appear before a Spanish Juez de Instrucción in a criminal trial against the National Crime Agency in Spain and the UK. As well as testify relating to conspiracy to pervert the course of justice in my false extradition.

SOCA (Serious Organised Crime Agency) stated in court that they had spoken to Paul Studley and Toby Childs and that they did not recall the phone call telling us to go back to the UK, due to a threat to our lives. SOCA stated this in court during my extradition hearing at Westminster Magistrates court. We don't believe Paul Studley or Toby Childs were asked by anyone, and want Studley, Childs and Formby in court to swear on oath in court.

SOCA perjured themselves twice in the UK extradition and were caught doing so by the magistrate on one occasion. They were forced to bring the real information and have never been charged for perjury. We believe the other occasion is this statement relating to the recollection of the phone call we made to them where they told us to go back to the UK as a matter of urgency for our security. Their entire extradition case pivoted on this statement. If what we are saying is true the extradition would not have stood. This is clear Conspiracy to Pervert the course of Justice, we want the people involved charged and dismissed and there assets seized pending damages claims.

You are liable to pay us compensation for the false extradition and we are suing you for that now.

This is the telegram that was sent to me by Charles Formby of the Seville consulate. It has the name Charles Axon on it. That was the name i was being held in prison under as a protected witness. Please note the phone number on the telegram, it was added to the document while at a meeting with an MI6 agent and a Norwegian intelligence agent who briefed me on the case when i was released from prison, without charge, and will be electro statically tested to the time 1993 in the coming court case.

On the other hand, having been in contact with the penitentiary centre of Alhaurin de la Torre where Mr Owens was incarcerated until 23 September 1992, they inform us that another person was subsequently admitted into the penitentiary of Jaen, by the name of Charles Samuel Axon, with whom Mr Owens shares some details such as date of birth and others, it is not known if this is the same person or not since, if it were the same person, it was not known because it was not stated on carrying out the comparison of finger-prints.

It would be imposible to get the documents below if the case was not already over, and i did not only get these documents i got all the investigation notes and evidence including physical evidence as i was to investigate the case as arranged with the judge by Charles Formby from MI6, the judge knew this and knew i was working for them. Please note the stamp in the top right corner of the document below; this is an official court document not a copy. Also the number that is there is a legally binding number, in that all public documents issued from any examining magistrate have to be by law sequential.

So its 100% proven that the case was over and somebody deliberately set this whole farce in motion re the extradition, i want everyone involved arrested and charged and damages.

The outcome of this Sumario was i was charged with nothing by order of the prosecutor not the judge, it was no case to answer.

Point 2: More NCA Perjury

In the extradition hearings and on my European arrest warrant, that was clearly all falsely processed, it stated that the police looked for me and could not find me. This was fraudulent and perjury. At that time i was corresponding with Sir Peter Fahy of Chief Constable of Cheshire, prior to that i was working with Scotland Yard with Detective Superintendent Michael Hoskins, i was in contact with Chief Constable of Humberside Police, Tim Hollis, as well as this and many other proves i have, i had national security cleared top level access to every secure data facility in the UK including the red flag centres at Racal Guarded by police with machine guns and Energis red flag centre the entire time i was in the UK.

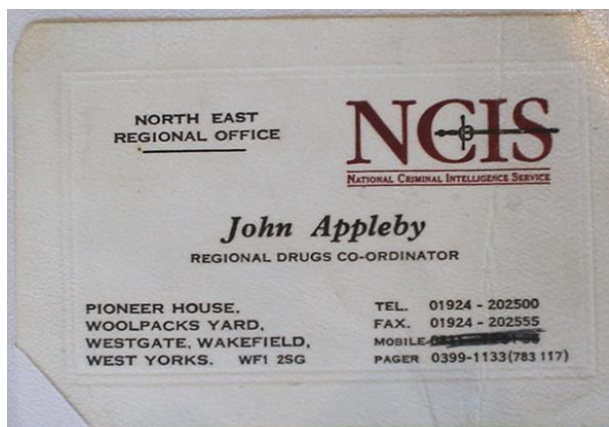
Because they supposedly could not find me it resulted in me being arrested at home and falsely imprisoned. Local Masons knew the arrest was to take place before it did, how could this be? The point here is there was no need to arrest me, it was staged by corrupt police. We want them arrested and thrown out of the police and their assets seized pending the outcome of their trial and civil litigation. I can prove 100% that this is perjury and so leads directly to conspiracy to pervert the course of justice.

Upon my arrival in the UK, sent by Paul Studley and Toby Childs (this was denied in court saying they could not remember), this evidence was given by SOCA not by the people themselves and so was hearsay, they lied. In the UK i was met by NCIS people, who knew who i was, and what i was doing. Within days, at my home, i was visited by two senior officers from the NCIS (National Criminal Intelligence Agency).

Also If no one knew where i was, how did they know to come to my house if they were not contacted by Toby Childs and Paul Studley? How did they find my house and pay me money they owed me? They were ordered to do this by the British Embassy in Spain. The entire extradition case pivoted on this lie. This was another direct lie to the EAW and to the courts, another case of perjury. If they had spoken to Toby Childs and Paul Studley, there was no way they would not remember, as was claimed by SOCA at court. So it can only be perjury. I want them arrested for Conspiracy to pervert the course of justice, and all assets seized pending the outcome of damages claims, and i want the information i have asked for.

Who lied to get the EAW we want them arrested and charged and assets seized pending damages cases, and we want to know everyone in the paper and electronic chain who was involved.

I was met by John Appleby and Chief (his words) Keith Crawley of NCIS

Point 3: My whereabouts in the UK prior to EAW:

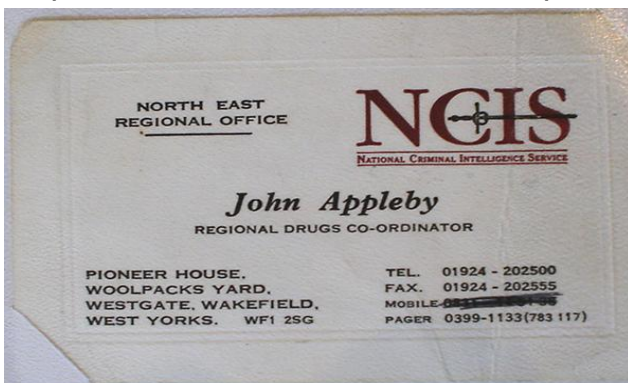
I was given a number by the National Criminal Intelligence Service to call on an armed response team any time night or day.

Calling In The National Criminal Intelligence Service Armed Response Unit:

I had figured out what was going on by the time i worte to my MP Sir Nicholas Winterton re people Gangstalking me and who stole my business. I was trying to sue Masons from MI5 for hundreds of millions of pounds, and others, and trying to get help from the Police.

I called the number I had been given for the NCIS (National Criminal Intelligence Service) armed response team. This is the Armed Response phone number at Wakefield, i called 013991133 and



gave my Agent code to call an Emergency armed response team to my location. My clearance Agent code was 783057, my NCIS Contact was Chief Keith Crawly who I was introduced to by John Appleby NCIS.

This has already been confirmed in the Royal Courts of Justice, UK High Court in London under National Security protocol held in CAMARA case number CO/5173/2009 (I have all the document should the you wish to read them, as you would not qualify for

security clearance through normal channels).

When i called in the armed response team from Birchenclyffe farm in Cheshire, a handling Agent from NCIS called me back. They said go to the Valley Lodge Hotel in Handforth. When i got to the meet location the person there was Dave Whiting who said he was with NCIS. I knew him from Wilmslow, they were all in bullet proof underclothes with big jumpers over them to cover who they were, as I entered the car park I could see they had the place locked down outside.

The point here is, how could the police not know where i was, if i had an armed response team on call!?

Dave Whiting told me at that meeting that he had Spoken with Toby Childs who was my liaison officer in Spain for MI6. At the royal courts of justice hearing the court agreed that as far as i was concerned both i, Toby Childs and Paul Studley all worked for MI6.

Dave Whiting NCIS?:

I want to know if Dave Whiting was acting for Cheshire Police or if he worked with the NCIS at that exact time, when i called in an armed response team?

The importance of this is that i believe he and Masons in the Cheshire police set this whole thing up, and could of even intercepted the call if they were bugging our home to cover what they were doing. It clearly was not NCIS as they were paying me. So was it the armed response team i met or did they just pretend to be them as they knew the protocol for armed response.

Was there collusion between this officer and others at Interpol which is run by the NCA at Manchester regarding the implementation of the EAW? This would of been to cover the lawsuit that i had wrote to the Chief Constable of Cheshire Mr Fahay at that time on the advice of my MP.

The INTERPOL National Central Bureau (NCB) for the UK is part of the National Crime Agency (NCA)

At the meeting at the Valley Lodge Hotel NCIS Meeting, I was taken inside and met what initially appeared to be two NCIS officers. They said what's the issue, I said we have been getting followed everywhere and threatened even on the farm where I lived. It was no longer safe there. We sat having a drink, Dave Whiting was with a Liverpool guy who he said was also NCIS.

I started explaining about what was going on, starting with Malcolm Edwards Stockport Mafia/Quality Street Gang putting up £100,000 for a business i set up before i knew who he was. Then Malcolm just walked away, I explained what had happened, and I said to them that someone drove cars off his garage forecourt and burned them, at this point Dave Whiting jumped in and said there was only one car burnt, I agreed, but wondered how he could know that! They knew all about it, I am sure these guys were not NCIS and I wish to get this confirmed in the UK part of the court case coming up on Conspiracy to pervert the course of justice and Gang Stalking to be filed in 2019.

I asked NCIS to get me a change of ID so we could move and carry on our business, as we could not make any money with all the Ring-fencing and Gang stalking going on. They said they would look into it, I heard nothing from them. This was also very odd and points at Dave Whiting trying to orchestrate a different set of events.

I want an investigation into David Whiting and Wilmslow police. Did they intercept the call to NCIS (either as paid cops by the QSG, or as Masons), as they were involved in the Ring Fencing by the Masons, Is David Whiting a Mason? Did he try and stop the truth getting out and perverted the course of justice? If so he did it with the Masons as the police had no authority to act. If this is true it is conspiracy to pervert the course of justice and reckless endangerment to life, I demand this is investigated and charges brought plus a civil lawsuit.

There was a third man sat away from us at the Valley Lodge NCIS Meeting, and I have unusually good peripheral vision. I was watching him listening to our National Security chat, and I pointed out that this man was looking, in fact I stared right at him for the first time and pointed him out he nearly fell off his chair.

David Whiting said don't worry about him he's with us. I recognise this man as being involved in the stalking that has gone on in Spain since, MI5? He contacted Philip Murphy in Spain and Essex and I saw him have a meeting with him about me, the meeting they had was at the end of some website work i had done. They had paid me around £27,000 pounds for work that was never live on the internet. This is more than odd and was an ongoing pattern that i can prove.

Philip Murphy needs to be brought before a Spanish court and questioned about it, is he undercover NCA or a paid informant? He's from Northern Ireland and i personally witnessed him talking to the Irish Drug Mafia over buying the London Pub complex in Spain worth £5,000,000 where he explained on the phone which people had to be paid with bungs for the nightclubs, including police and British Drug Mafia.

David Whiting also needs to be questioned in the courts in the UK. We already have a strong case of Perjury and perverting the course of justice about to be filed in the UK against the same agency now called NCA National Crime Agency (previously Regional Crime Squads formed up, due to the fact it was so corrupt it could no longer operate and was facing huge lawsuits. NCIS started and the same happened again and then SOCA Serious Organised Crime Agency and the same happened again, now we are filing a £4 billion pound lawsuit against them now called NCA along with others that will again end the organisation. Ever wondered why NCA keep changing their name?

I am not convinced that Dave Whiting was with NCIS at that time, he could have been local police Masons, who were involved in the harassment and mason Gangstalking or just helping out MI5. The point here is that this needs investigating so we know the answers for the coming court cases.

Terry Cousins NCA:

When the EAW was issued for my arrest, the police and everyone knew where i was, and i was well known. So why did the NCA come with police to my home if they did not even want me to go back to Spain? Which they clearly did not want to happen. The whole thing was staged and known to be happening by locals in advance.

They needed to destroy me right then, because i was filing a case for hundreds of millions of pounds against the people involved, Terry Plumber, Wayne Lochnor and Chris Britton all masons and working for MI5.

The whole thing was a set up, Terry Cousins NCA gave me the number of a specialist extradition lawyer, i got him to write it down in his own hand writing, i have the document.



I was later told by the Barrister from the Royal Courts of Justice, House of Lords and Supreme Court that the original lawyers ruined the case and that i should not be extradited, even the prosecutor Claire Dobbins said the case was a disgrace of British justice.

I want Terry Cousins charged with Conspiracy to pervert the course of justice, along with the lawyers, and i want a list of all present from the police and NCA at the arrest in Poynton, and i want to know how many were Masons and all their names?

When i left the house with the police, i was driven on a route where six cars came past with one headlight on, this was part of the Masons Gang Stalking that was going on previously, and only the police knew the route i was to be taken on, i want all Masons involved in this charged.

The lawyer we got from the company recommended by Terry Cousins NCA, Sian Williams, for the extradition hearings, committed criminal negligence. I showed Sian Williams the Spanish case papers proving the case in Spain was over. She told me not to show anyone the papers. I also showed her four letters that prove who did the crime, the extradition was for, the original judge saw these letters. Sian Williams said never show anyone until the trial if there is one in Spain

At the very first meeting with Sian Williams i offered as soon as i was at her office to go back to Spain if she phoned up and arranged bail to save millions in court costs to both states. She advised me not to go, and to go through the extradition process.

Our QC Barrister told us that the case was deliberately messed up by the first lawyers. Clearly part of the NCA Mason set up that went on. I want her and her bosses at the firm to be struck of as lawyers for criminal negligence and arrested for conspiracy to pervert the course of justice. Plus i want to file a civil case against their indemnity insurance policy for the maximum amount as well as sue each of them separately, so the law firm is disbanded.

Pete Murray NCA:

After several failed attempts to extradite me, including the refusal of the NCA to extradite me, against the ordered wishes of the court. The extradition was cancelled several times as no one would come to extradite me. In the end they asked me to go on my own to Heathrow as it kept failing. This is what i went to Heathrow with and met Pete Murray there.

At my extradition organised by the NCA to be on Friday the 13th by Masons in the NCA.

At that meeting Pete Murray received a phone call at the airport in the cafe, the person on the phone told him that if i did not want to go back to Spain they would see to it that i did not have to. And that i would be never found. He said on the phone to Pete Murry he was surprised i turned up as they were not going to look for me if i failed too.

I knew what they were trying to do was have me under their control to stop me filing the law suit for £2 billion pounds relating to the theft of my business by MI5 agents.

What they did not want is for me to go back to Spain and clear my name which was done in 5 mins at the original first court hearing 30 years ago where it was proven i had not been in the

house at the time of the crime. I was only sent to Malaga prison in Spain because i broke out of the Arresto Municipal local prison there, because of the breaches in human rights being perpetrated against me. Everyone knew that, as i left a letter for the judge explaining she can't treat people the way she did. They closed and sacked all the staff after i escaped and i booked into a local hotel.

Charles Formby of the FCO MI6 who told me i was in MI6, he also called the judge in the case Dona Blanca Esther Diez and told her that i was now working with MI6 and that i was to be given all the papers from the case, which the judge did. I still have them, i got them because the case was over. Proof that the extradition was false and fabricated by someone.

The NCA and others that set up the false extradition all knew this.

You must arrest all involved, cease all their assets for considerable damages claims coming.

Interpol and Europol Collusion With Other Security Services

30 Years ago I was originally arrested by Inspector Jimenez head of Interpol in southern Spain. He was the Husband of the Judge in the case a clear miscarriage of justice. The EAW that came through for me was supposedly instigated by Interpol, is this true? We want all information relating to this, who spoke to who, and the entire paper and electronic chain and the date stamps on all communications regarding the EAW. As the NCA have already been caught committing perjury over this exact fact, they falsified emails and dates time stamps of emails and were caught doing so in Westminster Magistrates Court by Judge Tubbs and we want them charged for this in a conspiracy to pervert the course of justice case and perjury.

Was Inspector Jimenez contacted to instigate it by bent Mason cops in MI5? Who set it in motion? and if so when and why?

I have all the court papers from the original case, including all forensic evidence from the court number 4 Marbella, proving the case in Spain was over as far as i was concerned. The court Judge Dona Blanca Diez was informed by Charles Formby of MI6 directly that i was investigating the case for the UK, and they were to provide me with every document from the case. The judge Dona Blanca Diez was on bail at this point facing four years two months in prison, that's what she told me herself for dereliction of duty and giving out evidence on a case unrelated to mine to someone she should not, this is a two year sentence in Spain. She also told me she had spoken with Formby and instructed the functionaries at her court to copy every document related to the case and copies of all physical evidence; these were all stamped and signed by the judge.

The dates and time stamps are critical in establishing that the arrest warrant was deliberately set in motion to stop me suing MI5 and MI6 for £2 billion pounds plus interest and other damages. The extradition was only started when i wrote to my MP accusing MI5 of theft of hundreds of millions. The chief constable of Cheshire who is a Mason was informed and was supposed to investigate it.

I have recently found out that Interpol is based at Manchester, and there could of easily been collusion between Masons to start the extradition.

It's clear that the NCB in Manchester could of done this on the say so of Cheshire Police as they were facing a situation re the theft of my business by MI5 Masons.

Europol Involvement:

During the set up and due diligence of the company, that Mason MI5 Agents stole from me. Terry Plumber and Wayne Lochnor were in a bar with me drinking in London. I was with a woman that i had just met a few days earlier who stayed at my flat in London she said she was from Denmark. Terry plumber picked her up in a bar literally above his head and took her outside to stop her telling me something, he told her that they would deal with it and to stay out of it. At that point Terry Plumber had never met the girl. I want her charged, she is with Europol or Norwegian intelligence or Norwegian Drug Mafia as the murdered guy was a trafficker of cocaine to his Norwegian night clubs as disclosed to me in a brief by MI6 and Norwegian intelligence service for my investigation into the British Drug Mafia.

The question here is why would a woman from Norwegian National Security come to me in the UK when they knew all about the case and had briefed me? Clearly there is another agenda running here.

I had already been briefed by Norwegian National Security on release from false imprisonment in Spain. A British MI6 Agent, who knew i was working with MI6, came to me with a Norwegian Agent, to the Bar Sol in the complex i lived in. The address they came too was Pueblo Guimar, 1st Portal, Apartment 1st floor C, Torre Blanca Del Sol, Fuengirola (same address as on my recruitment to MI6 telegram). This is within days of when i got out of prison, to brief me on what they knew about the murder and who he was, and who he was connected with. I want the names of these people? Who told them to go there, and where they got the information from that i was briefed with?

Electronic Surveillance/Targeted Individuals Program

As soon as i filed the case against the NCA in Spain with the justice ministry and informed the Poder Judicial (Ministry of justice, where i have a £5m damages case pending and being deliberately held up by the NCA). The NCA were interfering in the case for corrupt reasons, the NCA and MI5 electronic DARPA surveillance has started with RFID Implants done by a local dentist in Fuengirola. Please read attached document: **Audencia National Case final.pdf** for full details of the electronic surveillance.

The electronic surveillance has been used illegally with attempts to falsify information. The way they have fixed supposed evidence, re the electronic surveillance, is running two conversations side by side asking questions until you respond and then substitute the conversation with the second one, we have recordings of them doing this. Was this done illegally to continue the surveillance and prolong the whole thing hoping that passage of time will apply to the legal retaliation of suing them for billions of pounds?

They have also been saying things like "he did it" over and over and mentioning the murder weapon, which i have never mentioned the murder weapon to anyone. How could they know this information? Only a corrupt Spanish judge could give them the information, this is a criminal offence in Spain with a mandatory prison sentence of two years. I am filling this as part of the Audencia National/EU case against all security services involved and the courts and governments.

As a matter of coincidence, the Judge in the original case was charged and convicted of this exact offence, she was later released after threatening to go to the media about the Spanish Judicial Mafia, she was then re instated and moved to court number two Seville, the corruption is endemic

in Spain. Was she approached for this information and case file? If she was she should go to prison for it. Whoever gave out this information on a supposedly open case at that time is liable to go to prison.

This is the article where Dona Blanca accuses the Justice Mafia and says she will expose them, at this point her house was embargoed facing a £500,000 fine and up to 4 years two months in prison.

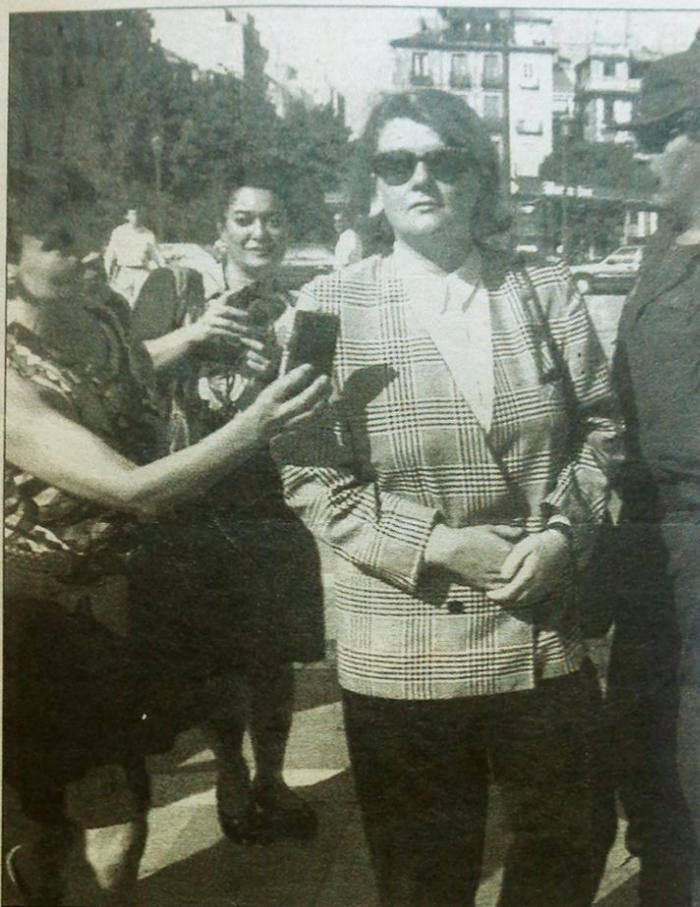

While i was in Spain waiting to supposedly be charged for a case that was already over. 4 judges refused to touch the case, and 4 prosecutors also refused, as it was so corrupt. The courts never spoke to me regarding the false case in 8 years. Now they won't give me the papers for the case because they know it proves conspiracy to pervert the course of justice. 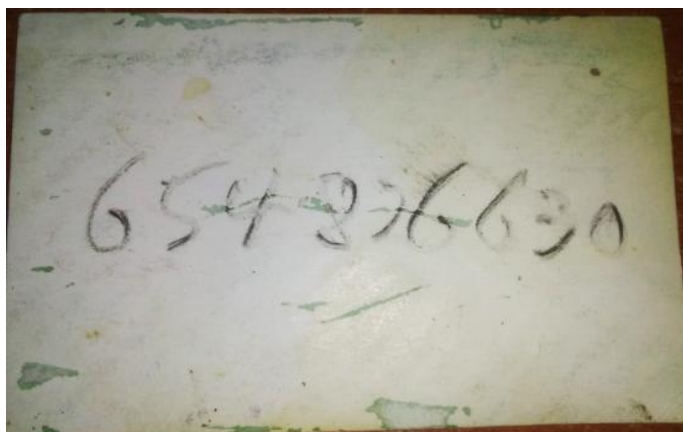
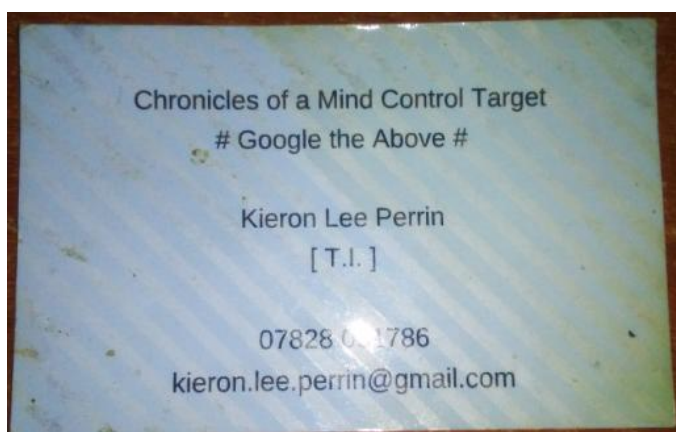
Kieron Lee Perrin:
